

CM Rekha inaugurates new school block in west Delhi

Delhi Chief Minister Rekha Gupta on Tuesday inaugurated a new school building block at a Sarvodaya Vidyalaya in Mansarovar Garden and said her Government is committed to improving infrastructure and learning facilities in schools.

The chief minister also inaugurated the Information and Communication Technology (ICT) Laboratory in Mansarovar and a District Institute of Education and Training at Dilshad Garden. Cabinet Minister Ashish Sood, MLA/Harish Khurana, and several other dignitaries were present at the programme. Speaking on the occasion, she said the BJP dispensation aims to make schools under the Delhi Government a preferred choice for parents, on par with or better than private institutions in terms of quality, facilities and infrastructure.

She said real success in the education sector would be achieved when parents themselves choose Government schools for their children. The Chief Minister said that the Government aims to make Delhi the state with the highest number of smart classrooms, computer labs, language labs, modern sports



facilities, and robust educational infrastructure in the country. Alongside academics, focused attention is also being given to sports and nutrition.

The chief minister also acknowledged the role of public-private partnerships, including support from the Ladli Foundation and the American India Foundation (AIF), in strengthening digital education.

A total of 101 computer labs have been set up in Government schools through such collaborations, with more than 2,000 computers provided so far, she added.

At Sarvodaya Vidyalaya, Mansarovar Garden, the Chief Minister inaugurated a newly

constructed ground-plus-three-storey school building comprising 29 classrooms, developed in accordance with modern standards and academic requirements. Similarly, a new ground-plus-three-storey building was inaugurated at the DIET campus, Dilshad Garden.

The facility includes 19 classrooms and is equipped with modern amenities to support teacher training and educational innovation.

Education Minister Ashish Sood said meaningful change in education is reflected in classrooms and laboratories rather than publicity campaigns. The Government was prioritising spending on

school infrastructure, including classrooms and ICT facilities, to bridge the digital divide among students, he said. Sood said access to computers and technology-enabled learning was crucial as most competitive examinations are now computer-based.

The Education Minister informed that more than 7,000 new computers have been provided to Delhi Government schools in less than a year. Tenders for 7,000 smart blackboards have been completed. In the next four years, smart boards will be installed in 21,000 classrooms from Classes 9 to 12, with a five-year maintenance guarantee.

Govt launches 10-day Vasantotsav 2026 cultural series

The Delhi Government on Tuesday inaugurated a ten-day cultural series titled Vasantotsav 2026 — Bhajan Clubbing. The initiative aimed at connecting young people with India's spiritual and cultural traditions through contemporary musical expression.

Chief Minister Rekha Gupta launched the programme at Ramjas College, University of Delhi, marking the beginning of events to be held across multiple Delhi University campuses till February 19.

The Chief Minister described “Bhajan Clubbing” as an innovative platform that blends devotion, culture,



and youthful energy.

She said the initiative reflects a growing cultural consciousness among young people and offers a modern format to experience bhajans and kirtans without losing their spiritual essence. The launch event featured

a devotional performance by Leela Band, which drew participation from students as well as dignitaries present at the venue.

The Chief Minister said bhajans and kirtans form the soul of Indian cultural life, and initiatives such as Bhajan

Clubbing help reinterpret these traditions for younger audiences.

According to her, Delhi is witnessing a rare confluence of devotion and modern expression, where spirituality is being experienced in a new and accessible form.

Art, Culture, Language, and Tourism Minister Kapil Mishra, who was also present at the event, said the Delhi Government is committed to making the capital a centre of cultural and artistic activity.

He said Bhajan Clubbing represents a youth-centric cultural movement inspired by the Prime Minister's call to preserve and celebrate India's heritage while actively involving young citizens.

Govt shuts down DFC lending agency over mounting losses

The Delhi Government has shut down its lending agency Delhi Financial Corporation DFC due to mounting losses, and formed a nine-member committee to complete its winding up.

The winding up of the DFC was notified by the finance department on February 6. The decision to shut the entity was taken in a Cabinet meeting last month, chaired by Delhi Chief Minister Rekha Gupta, official said.



The “acute financial constraints” faced by the DFC, which provided loans to medium, small and micro projects, were flagged in a meeting of its board members

in November last year.

The board was apprised that the share capital of DFC had been eroded and the losses accumulated to the tune of ₹42 crore. It was also not in a position to repay the total outstanding loan of ₹80 crore it owed to the Delhi Government as of September 2025.

Further, the corporation's entire capital base and reserves were completely eroded, and its net worth showed a negative growth of ₹15 crore, official documents showed. In exercise of the

powers conferred by Section 45 of the State Financial Corporations Act, 1951, and all other powers enabling in this behalf, the Lieutenant Governor of the National Capital Territory of Delhi has ordered winding up the DFC, the finance department said.

“The DFC will stand wound up with effect from the date of publication of this Notification (February 6, 2026) in the Official Gazette,” the notification read. All operations of the corporation, including sanction of fresh loans, stand ceased, it said.

PWD orders safety checks after Janakpuri tragedy

The Public Works Department (PWD) has issued fresh directives on Tuesday to carry out safety inspections of flyovers, underpasses, roadside drains and streetlights following the death of a man who fell into a pit dug in Janakpuri for Delhi Jal Board work.



works must be properly barricaded at all times during the day, and at night, the order said. “Install adequate reflective signage, warning boards,

blinkers and caution tapes as per prescribed safety norms. No trench, pit, or excavated portion of the road shall be left open without proper protection under any circumstances,” the PWD said.

Regular night inspections must be carried out, particularly at sharp curves, junctions, medians, pedestrian crossings, bus stops, flyovers, underpasses, and other accident-prone locations, it added. The

order follows directions issued by the Delhi Chief Secretary Rajeev Verma earlier.

Daytime inspections will assess the physical condition of poles, wiring, earthing, and foundations, the official order further said. “Any flickering, dim, or partially functional lights are to be treated as defective and repaired immediately, with temporary lighting arrangements provided if required,” the PWD said.

A 37-year-old woman was shot dead inside her home in Delhi's Jungpura area late Monday night. According to the police, the woman died due to an accidental firing involving her own son. The victim, identified as Sumati, was brought dead to Moolchand Hospital with a gunshot wound to her face. Police investigations revealed that the shot was fired by Sumati's 18-year-old son, Tarun, who has been arrested. The police said that a PCR call regarding the incident



was received at around 10.39 pm on Monday at the Lajpat Nagar police station. Subsequent inquiry traced the place of occurrence to Pant Nagar, Jungpura, falling under the jurisdiction of Hazrat Nizamuddin police station. According to senior police

officers, the incident happened inside the family's house in the JJ cluster, where Sumati lived with her husband and children. Earlier that evening, Tarun had allegedly procured an illegal country-made pistol from an unidentified person

in the Ashram area. Later that night, while handling the firearm inside the house, he began showing it to his mother. During the demonstration, the pistol accidentally discharged, and the bullet struck Sumati in the face, causing fatal injuries.

“The accused has disclosed that the firing was unintentional and occurred while he was showing the weapon to his mother,” a senior police officer said. “There was no previous enmity or domestic dispute reported. Prima facie, it appears to be a case of reckless handling of an illegal firearm.”

CM launches Lakhpati Bitiya Yojana to support girls' education

The Delhi Government on Tuesday launched the Delhi Lakhpati Bitiya Yojana, an expanded and restructured version of the Ladli Scheme. The scheme aims to ensure financial security and uninterrupted education for girls from economically weaker families from birth to higher education. Announcing the scheme, Chief Minister Rekha Gupta said the initiative seeks to ensure that no girl child in Delhi is forced to discontinue her education due to financial constraints. She said the scheme will also help create a long-term savings corpus that grows as a girl achieves key educational milestones and matures into adulthood. Under the new scheme, the Government will provide financial assistance of up to ₹56,000 per beneficiary. The amount will be deposited in

phased instalments linked to age and education milestones, starting from birth and continuing through graduation or diploma-level studies. The deposited amount will be invested through a structured financial instrument and, with interest, is expected to mature to more than ₹1 lakh. The final amount will be credited directly to the beneficiary's Aadhaar-linked bank account. "This is an investment in the future of our girls and the future of the country," the Chief Minister said. She added that the Government is determined to ensure that no girl drops out of school or college for want of funds. As girls progress through education, the Government will continue to support them financially. The Chief Minister said the Ladli Scheme, launched in 2008, had not been adequately implemented over the years. After assuming office, the present Government found

that a large number of maturity accounts remained unclaimed. She said more than 1.86 lakh such accounts were lying pending, meaning the money meant for beneficiaries had not reached them on time. To address this, the

Government identified 30,000 beneficiaries in 2025 and disbursed ₹90 crore that had remained unclaimed. The Chief Minister said another 41,000 beneficiaries have now been identified and ₹100 crore will be released shortly. In total, ₹190 crore belonging to

beneficiaries is being ensured and delivered, she said. Eligibility conditions have been slightly modified under the revamped scheme. It applies to girls born in Delhi whose families have lived in the city for at least three years and whose annual family

income does not exceed ₹1.20 lakh. Benefits are limited to two surviving girl children per family. Girls can be registered within one year of birth or at later stages, such as admission to Class I, VI, IX, or XI, or upon admission to a recognised graduation or diploma course. A key expansion under the scheme is the inclusion of girls pursuing graduation or professional diploma courses in government-recognised institutions anywhere in India. This includes universities

and colleges affiliated with the UGC or other statutory bodies. Conditions have also been relaxed for girls living in child care institutions under Government protection to ensure wider inclusion. Financial assistance will be deposited at different stages of a girl's educational journey, beginning at birth and continuing through school and higher education. The Government will deposit the assistance amount in instalments at critical stages: ₹11,000

at the birth of the girl child, ₹5,000 on admission to Class I, ₹5,000 on admission to Class VI, ₹5,000 on admission to Class IX, ₹5,000 on passing Class X, ₹5,000 on admission to Class XII, Another ₹20,000 will be credited to the accounts of beneficiaries in phases on completion of diploma or graduation. The deposited amount will earn interest over time, creating a substantial maturity value. The maturity amount can be claimed once the beneficiary has passed Class XII and attained the age of 18, or after completing graduation or a diploma and attaining the age of 21. If educational milestones are not met within the prescribed age, or if the amount remains unclaimed, the funds will be credited back to the Government. The Chief Minister said the entire process, from application to payment, will be fully digital and transparent.

Over 600 get lifetime memberships of Roshanara Club

Govt directs officials to be present during deliberations of committees

To streamline the legislative process and ensure that the Delhi Assembly has direct access to the expertise required for effective governance, the State Government has directed officials to be present during deliberations of the committees. This directive issued mandating the presence of all administrative secretaries and officials on Tuesday is to ensure that policy-level discussions are supported by the primary decision-makers of each department. The order was issued by the General Administration Department. The circular emphasises that House Committees may regularly require the attendance of



senior departmental officers for specialised presentations, deliberations, and the furnishing of vital information. To maintain the highest standards of accountability, all administrative secretaries are now officially requested to attend these committee sittings personally whenever summoned by the Assembly Secretariat. This move ensures that policy-level discussions are supported by the primary decision-makers of each department.

Recognising the complexities of administrative schedules, the government has established a protocol for unavoidable absences. In instances where an administrative secretary is unable to attend due to unforeseen circumstances, a suitable senior officer fully conversant with the specific subject matter must be deputed. This substitution requires prior approval and is intended to prevent any delays in the submission of records or the conduct of official proceedings, maintaining the momentum of legislative oversight. Furthermore, the Delhi Government has called for the timely submission of all documents, reports, and materials requested by the House Committees.

India climbs up in corruption index

India climbed five places to the 91st position out of 182 countries and territories in the 2025 Corruption Perceptions Index (CPI) released on Tuesday.

Denmark retained its position at the top of the index, scoring 89 points, ahead of Finland and Singapore. At the other end of the scale were South Sudan and Somalia, both registering nine points, followed by Venezuela. The leading three nations saw no change, while South Sudan's one-point gain brought it level with Somalia. While the US has been ranked at the 29th spot, the UK bagged the 20th spot.

According to Transparency



International's latest CPI report, India's score has gone up by one point since previous year while its rank has improved from the 96th position. There has been a slow growth in anti-corruption progress in Asia Pacific as many countries witnessed public anger in the previous year, the report said.

According to report, 2025 saw a wave of anti-corruption protests led by Gen Z, mostly

in countries in the bottom half of the CPI whose scores have largely stagnated or declined over the past decade. Young people in countries such as Nepal (34) and Madagascar (25) took to the streets to criticise leaders for abusing their power while failing to deliver decent public services and economic opportunity.

"The 2025 Corruption Perceptions Index shows that corruption remains a serious threat in every part of the world, although there are limited signs of progress. "Leaders must act to tackle abuses of power and the wider factors driving this decline, such as the roll-back of democratic checks and balances, and attacks on independent civil society," the report said.

"Anti-government protests in many parts of the world show that people are fed up with unaccountable leadership and are demanding reform," it added.

The CPI ranks 182 countries and territories worldwide by their perceived levels of public sector corruption. The results are given on a scale of 0 (highly corrupt) to 100 (very clean). The report also listed India among countries "dangerous for journalists reporting on corruption".

"When journalists are attacked or killed for investigating corruption, power cannot be held to account effectively and corruption tends to worsen. Since 2012, in non-conflict zones worldwide, 829 journalists have been murdered. "Over 90 per cent of

these killings happened in countries with a CPI score lower than 50, including in Brazil (35), India (39), Mexico (27), Pakistan (28) and Iraq (28), which are particularly dangerous for journalists reporting on corruption," it noted. "While 31 countries have significantly reduced their corruption levels since 2012, the rest are failing to tackle the problem – they have stayed stagnant or got worse during the same period. The global average has fallen to a new low of 42, while more than two-thirds of countries score below 50.

And people are paying the price, as corruption leads to under-funded hospitals, unbuilt flood defences and blights the hopes and dreams of young people," it said.

IYC holds protest over Centre's silence on serious issues

The Indian Youth Congress (IYC) on Tuesday held a protest alleging that the Central Government has remained silent on serious issues, including references made in retired Army Chief General Manoj Mukund Naravane's unpublished "memoir".

The demonstrators alleged a lack of transparency in the India-US trade agreement and a compromise on the country's security at the China border.

A spokesperson of the Indian Youth Congress claimed that more than 150 people who were protesting



peacefully at the Jantar Mantar were detained by the police.

In a social media post, IYC National President Uday Bhanu Chib said, "Every single worker of IYC is on the streets. When the leadership starts compromising on national interest, the youth cannot sit quietly. We will keep fighting until we get answers." "Today, the entire truth is staring the country in the face. The prime minister's

silence is raising many questions: Why the mysterious silence on the Epstein files? Why the lack of transparency in the India-US trade agreement? Why compromise on the country's security at the China border?" he said.

"The Indian Youth Congress organised a gherao of the Prime Minister's residence on Tuesday. Workers from across the country gathered at Jantar Mantar for this gherao," IYC said in its statement. It added that when the Youth Congress workers, led by IYC President Uday Bhanu Chib, were moving towards the gherao, the Delhi Police barricaded them and detained over 150 Congress workers.

Qayamat day will never come, Babri structure won't be rebuilt: Yogi Adityanath

Uttar Pradesh Chief Minister Yogi Adityanath on Tuesday asserted that the day of *Qayamat* (doomsday) will never come and hence the Babri Masjid will never be rebuilt.

Speaking at an event in Barabanki, Adityanath said, "We had said that '*Ram Lalla, hum aayenge, mandir wahi banaayenge*' (Child Ram, we will come and build the temple right there).

Has the temple been built? Is there any doubt?" The audience replied by chanting *Jai Shri Ram*.

"The day of 'Qayamat' (doomsday) will never come, and hence the Babri structure will never be rebuilt.

Those who are dreaming of the day of *Qayamat* will rot away, that day will

come," Adityanath said.

Settling the fractious Babri Masjid issue, a Supreme Court verdict on November 9, 2019 backed the construction of a Ram temple by a trust at the disputed site in Ayodhya, and ruled that

an alternative five-acre plot must be found for a mosque in the Hindu holy town.

The dispute over the site of Babri Masjid, a three-domed mosque built by or at the behest of Moghul emperor Babur, dates back more than a century with Hindus contending that the invading Muslim armies had razed an existing Ram temple to erect the mosque.

However, it turned into a legal dispute in 1885 when a mahant went to court seeking permission to build a canopy outside the mosque.

The plea was dismissed. In December 1949, unidentified miscreants spirited a Lord Ram idol into the mosque. The structure was destroyed by a large mob of kar sevaks on December 6, 1992.

Property dealer found dead in south Delhi

The body of a 49-year-old property dealer was found hanging inside his residence in the E-2 block of Vasant Kunj on Monday evening. The man, who was living alone and separately from his family, was found in a partially decomposed state, indicating that the death may have occurred sometime before it was discovered.

According to the police, a call was received at the Vasant Kunj South police station at around 6.19 pm reporting a suspected suicide at a house in Vasant Kunj.

Acting on the information, the enquiry officer, along with the beat staff, rushed to the spot and found the house locked from the inside.

The PCR personnel and a Delhi Fire Services team official opened the door forcibly. Inside, the police found the body of a man hanging from a ceiling fan with the help of a plastic rope.

Officials said the body was emitting a foul smell and appeared to be partially decomposed, suggesting that the man had died at least a few days earlier. The crime team was called to inspect the spot, and after preliminary examination.

Interim trade pact with US one-sided: Akhilesh

Samajwadi Party supreme Akhilesh Yadav on Tuesday dubbed the interim trade agreement with the United States as "one-sided" and alleged that it will hurt the farming community, as agricultural imports will hit farming in India.

Participating in the discussion on the Union Budget in the Lok Sabha, he also said the agreement will damage the prospects of the industry and push back the 'Made in India' and *Aatmanirbhar Bharat* (self-reliant India) initiatives of the Government.

He questioned the delay in reaching an agreement with the US, saying that if this is what India gets in return, this could have taken place 11 months ago.

Referring to the Union Budget presented on February 1, the former Uttar Pradesh chief minister alleged that it is "directionless" and does not help in fulfilling the dreams of a developed India by 2047.

He said the interim agreement will flood Indian markets with US agri products, and the farmers will have nothing to grow in their fields. He said the Budget too has nothing for the farmers who will be unable to save for the future.

He claimed that while "invisible people" will benefit from the Budget, the Government has forgotten the poor, Dalits, minorities and women.

Referring to his home state of Uttar Pradesh, Yadav said the statue of Ahilya bai Holkar was recently razed at the historic Manikarnika Ghat in Varanasi, which is represented by the Prime Minister in the Lok Sabha.

He alleged that about 100 temples have been bulldozed in the holy city and the "pradhan" constituency of Varanasi has been deprived of a metro rail and modern highway due to paucity of funds.

Yadav also claimed that the Government has done little in the healthcare sector, and funds for flagship schemes have been constantly dwindling.

Delhi Government withdraws all cases filed by AAP against Centre

The Rekha Gupta government has withdrawn all cases filed by the previous Aam Aadmi Party (AAP) administration against the Union government, the Lieutenant Governor, and several senior bureaucrats.

This follows the Supreme Court's permission for the Delhi government to withdraw multiple cases on key administrative and policy issues, which had been a major point of contention between the former AAP regime, the Centre, the L-G's office, and Delhi government bureaucrats.

These cases filed by the former AAP government over a period of time included the



appointment of Delhi Electricity Regulatory Commission (DERC) chairman, control over service-related matters, implementation of Pradhan Mantri Ayushman Bharat Health Infrastructure Mission, funding for the Delhi Jal Board, appointment of lawyers in the Delhi riot cases, and the constitution of a high-level committee on Yamuna river pollution. When the AAP was in power, the Delhi gov-

ernment and the Lieutenant Governors - Najeeb Jung, Anil Baijal and Vinai Kumar Saxena - frequently clashed over one issue or the other and several of these disagreements made their way to the courts. The AAP government, led by Arvind Kejriwal and then Atishi, complained that the Lieutenant Governor (LG) was deliberately hampering the implementation of its policies. The LG, on the other hand, accused the AAP of not cooperating with him. The tussle with the LG is seen as one of the factors that led to the AAP's rout in last month's Delhi elections.

According to the officials, the law department of the Delhi government began the withdrawal process for these cases shortly after the BJP

assumed power following the Assembly elections in February 2025.

Continuing with these cases posed legal challenges, as it would have been difficult for the BJP, which governs Delhi, to pursue cases against its own government at the Centre and its appointed L-G. Additionally, persisting with the cases would have wasted government resources without producing any benefits, an officer stated.

In May 2025, the Supreme Court allowed the Delhi government to withdraw seven cases filed against the L-G. During the same month, the Delhi High Court also permitted the government to withdraw its petition challenging the L-G's decision to appoint lawyers to argue cases related

to the farmers' protest and the 2020 Delhi riots.

An internal proposal moved by the law department stated that such litigation caused "hardship" to the bureaucracy and resulted in "administrative paralysis," delaying policy decisions and execution of projects.

The withdrawn cases also included one concerning the 2023 ordinance promulgated by the president, which amended the GNCTD Act of 1991, the interpretation of Section 45D of the Act, appointments to the DERC, cessation of funding, and issues related to the alderman case pending before the Supreme Court. Officials noted that the L-G Secretariat had approved the proposal to withdraw these cases. The

AAP and the LG were at loggerheads over the appointment of the Delhi Electricity Regulatory Commission chairman because the party believed that letting the Centre control the body could lead to the power subsidy scheme — which was very popular among voters — being ended. In 2020, then LG Anil Baijal was accused by the AAP of interfering in the appointment of public prosecutors to argue cases linked to the Northeast-Delhi riot cases. Furthermore, the Health Department submitted applications to withdraw cases filed by former minister Saurabh Bharadwaj.

There were approximately eight to nine such cases filed by former AAP ministers, officials said.

Mumbai to recover 61 tonnes plastic via waterway barriers

At least 61 tonnes of plastic is expected to be recovered every year from Trombay and Malad waterways in Mumbai, where barriers will be installed in phases to stop the flow of plastic waste into the Arabian Sea and the Indian Ocean, officials said on Tuesday.

The initiative is being led by The Ocean Cleanup, a Netherlands-based non-profit



organisation that develops technologies to remove plastic from the oceans, in collaboration with the Municipal Corporation of Greater Mumbai and the Maharashtra Pollution Control Board (MPCB).

"Mumbai will witness the deployment of barriers to stop the flow of plastic waste into the Arabian Sea and the Indian Ocean. The first deployments will focus on the Trombay and Malad waterways, identified through a data-driven analysis

as significant contributors to ocean-bound plastic waste.

"The technology is scheduled for deployment over 2026. Once operational, these initial systems are expected to recover 61 to 92 tonnes of plastic per year. Research found that 80 per cent of marine litter along India's coastlines is made up of plastic," the Ocean Cleanup said in a statement. The deployment, which will kick off before the monsoon season arrives, will take place in phases.

Congress MP seeks annual social justice report in Parliament

Rajya Sabha Congress MP Mukul Balkrishna Wasnik on Tuesday asked the Government to come out with an annual report on social justice and table it in Parliament on the lines of the economic survey.

The Government tables economic survey in Parliament prior to the Union Budget. Raising the

issue during Zero Hour in the House, Wasnik said India should institutionalise an annual report on the state of social justice and table it in Parliament just like the economic survey.

"This report should serve as a data-driven strategic guide to uphold the constitutional values of equality and inclusivity, and should be available for discussion in and outside Parliament,"



he said. The Congress MP said the report on social justice must systematically evaluate existing legal and policy frameworks to ensure they meet constitutional mandates.

It should focus on security to examine the implementation of various schemes and laws that exist for the protection of the life and dignity of persons from the disadvantaged sections.

Govt tightens AI rules, cuts social media...

It further clarifies that the definition will not apply to content that is edited or formatted in good faith for technical corrections, educational or research purposes, and for improving accessibility. The notification mandates platforms to prominently label AI-generated content and urged them to embed synthetic content with identifiers. The notification added platforms will have to make "reasonable efforts" and allow identification through embedded metadata or other technical means, rather than only visible disclosures. Platforms are also required to send periodic reminders — at least once every three months — about the rules around AI content and the consequences of violating them.

Expect to see these show up in updated terms of service, privacy policies or in-app notifications. "For the removal of doubts, it is hereby clarified that the responsibility of the significant social media intermediary shall extend to taking reasonable and proportionate technical measures to verify the correctness of user declarations and to ensure that no synthetically generated information is published without such declaration or label", the notification added.

mining transparency and public confidence. They also highlighted allegations of advance manipulation and irregularities in the newly introduced postal ballot system, raised by participating political parties, which have further deepened doubts about electoral neutrality.

According to the statement, proceeding with the election without conducting an independent, credible investigation into these allegations has called the neutrality of the Election Commission into question. Such conduct, they argued, is inconsistent with the spirit and intent of Article 118 of the Constitution, which mandates an independent and impartial Election Commission.

Quoting Supreme Court Advocate Aslam Mia, the statement emphasized the broader constitutional implications of the situation. "An election is not merely a procedural exercise; it is the highest expression of the sovereignty of the people," Mia said. "For an election or referendum to be legitimate, it must be conducted under conditions that ensure political neutrality, equality of opportunity, freedom of expression, transparency, and public confidence. Unfortunately, the prevailing circumstances fail to satisfy these fundamental constitutional and democratic requirements in the upcoming 13th National Election and Referendum."

Mia further noted that the absence of a level playing field, the erosion of institutional independence, restrictions on civil and political rights, and the lack of public trust render the election con-

stitutionally questionable. "A referendum held without the largest political party like the Bangladesh Awami League, genuine public participation, and informed consent cannot reflect the true will of the people and therefore lacks democratic validity," he said.

The lawyers stressed that under constitutional principles and international democratic norms, any election conducted without credibility, inclusiveness, and fairness is liable to be rejected by citizens. Participation in such a process, they warned, risks legitimizing an outcome that does not genuinely represent popular sovereignty.

However, BNP Vice President and Mohila Dal leader Zeba Amina Khan urged voters who have decided not to vote to reconsider, calling on them to "come out of their homes and cast their votes for a better Bangladesh." She said, "Sheikh Hasina has left the country with her family, but not the citizens who supported the Awami League. Now it is our responsibility to take care of them."

Man falls into open drain in Rohini

"Our teams reached the site soon after receiving the call. Rescue efforts are in progress," a senior police officer said, adding that the operation is challenging due to the depth of the drain and limited visibility.

Police said the identity of the man who fell into the drain has not yet been confirmed. Rescue teams are using torches and specialised equipment to scan the drain and nearby stretches. The area has been cordoned off to prevent further mishaps.

Officials added that civic agencies would be asked to provide details about the maintenance of the drain and whether proper safety measures were in place. Any further legal action will depend on the findings of the inquiry.

With two serious incidents reported within a span of days, questions are being raised about public safety and monitoring of infrastructure works in Delhi. Authorities said they are reviewing safety arrangements at vulnerable locations across the city as rescue operations in Rohini continue.

Launching the Annual Nationwide Mass Drug Administration Campaign for the elimination of lymphatic filariasis, Nadda pointed out that ensuring direct observation of drug consumption and addressing public hesitancy towards medication remain key concerns, which must be tackled through intensive awareness, community engagement, grievance redressal, and trust-building measures.

MP Kartikeya Sharma urges Govt to regulate online gaming

Rajya Sabha MP Kartikeya Sharma on Tuesday urged the Government to regulate online gaming, from development to streaming, to ensure that the digital space is safe for children.

Raising the issue during Zero Hour in the House, the independent MP also demanded that the Government should grant official sports status to eSports, which is recognised globally.

"I want to address a digital frontier that is full of promise as it is of peril. I am talking about the world of electronic gaming as we march towards the vision of a Viksit Bharat in 2047. We must

recognise the Orange Economy. Our creative and digital sector is no longer a peripheral industry. It is a vital pillar of our USD 1 trillion digital economy goal," Sharma said.

He said that India's creative economy is valued at about \$30 billion, contributing to nearly 8 per cent of our working population.

"However, we must distinguish between two very different realities within the sector. On one hand, we are witnessing the crisis of unregulated amateur gaming and its impact. The sprawling nature of unregulated amateur online gaming has led to grave repercussions," Sharma said, as he referred to death of some children because of game addiction.



Clinical studies now show a direct link between excessive, unregulated gaming and the rise of ADHD, acute anxiety and depression amongst our children and youth, Sharma said.

"As a parent, not merely as a member of parliament, I request the Government to regulate the entire ecosys-

tem from game development to streaming, and mandate game audits to ensure these digital spaces are safe for our children,"

He emphasised the need to create a safe and conducive ecosystem.

On the other hand, Sharma said there is a potential for professional eSports, which

largely remains untapped.

"We have millions of serious, highly skilled electronic gamers who are passionate about this craft. India now boasts of 500 million amateur gamers, the largest gaming audience in the world, and lakhs of professional gamers," he said, and added that India's gaming market is currently valued at about \$3.7 billion and projected to soar to \$10 billion by 2030.

He further said the animation, visual effects, gaming and comics (AVGC) sector alone would require roughly about 20 lakh skilled professionals by 2030.

"It is a great opportunity for our youth, for employment, particularly to unlock the full value of gaming

design development professional leagues. I urge the Government to grant official sports status to eSports, as they are also being accepted by international competitions, Olympics and other bodies," Sharma said.

In her Zero Hour mention, Sumitra Balmik (BJP) had expressed concern over the increasing use of mobile phones among children and their exposure to social media.

"Phone has become an addiction among them," she said, and added that children keep vying for maximum likes on their social media posts. The BJP member emphasised the need to implement a digital detox initiative to promote the overall well-being of students.

Shashi Tharoor slams India-US deal as pre-committed purchase agreement

The India-US interim trade deal looks more like a "pre-committed purchase agreement" that overturns every principle of reciprocity, Congress MP Shashi Tharoor said on Tuesday and slammed Union ministers S Jaishankar and Piyush Goyal for playing "ping pong" when questions are posed.

Initiating a debate in the Lok Sabha on the Union Budget, Tharoor said the government's claim that India has secured a "better deal" than China, Vietnam, or other Asian economies does not

withstand scrutiny.

"While India may have obtained tariff reductions of one or two percentage points, no East Asian economy has agreed to deliberately dilute its trade surplus with the

United States through guaranteed purchase commitments," he said.

The Congress MP from Thiruvananthapuram asked how one could speak of a "reciprocal tariff" of 18 per cent on

one side and zero per cent on the other. "It looks less like a free trade arrangement and more like a pre-committed purchase agreement that overturns every principle of reciprocity," he said.

At a time when India's total bilateral trade with the US stands at roughly ₹130 billion and a trade surplus of nearly ₹45 billion, the Government has surprisingly promised to buy ₹500 billion worth of American goods over five years, he said.

Tharoor argued that this effectively converts a surplus into a long-term deficit by executive assurance rather than by market demand.

Ugly scenes could have erupted in Lok Sabha: Rijiju

munication rather than conflict. Thackeray noted that the regional sentiment in the southern states like Tamil Nadu and Karnataka is fervent. There is a similar sentiment in Punjab, West Bengal and even in Gujarat.

to resentment among locals, leading to outbursts, he noted. Will Bhagwat call it a disease? the MNS president asked.

During an event in Mumbai over the weekend, Bhagwat interacted with people from different walks of life and responded to a series of questions. On the language row, he had said the "localised disease" should not spread.

Reacting to it, Thackeray

said, "If Bhagwat feels love for language and state is a disease, then a majority of the states in the country suffer from it."

Thackeray said Bhagwat did not give these "sermons" to Gujarat when thousands of people from Uttar Pradesh and Bihar were driven away from there. Why were such lessons not given to Karnataka, Tamil Nadu, Andhra Pradesh, West Bengal and Punjab? he asked.

The Deputy CM later attended her first cabinet meeting, chaired by Chief Minister Devendra Fadnavis.

Himanta files ₹500 cr defamation case against Congress leaders over land grabbing charges

Assam Chief Minister Himanta Biswa Sarma on Tuesday filed a ₹500 crore defamation case against Congress leaders for their "land grabbing" allegations against him and his family. He accused Congress leaders Jitendra Singh, Bhupesh Baghel and Gaurav Gogoi of making "false, malicious and defamatory allegations" during a recent press conference, leading to the legal suit against them.

"Over the last few days,

Congress leaders have been saying that I have benami land of 12,000 *bighas* (over 3,960 acres). I have filed a case in court so that they can submit the list before the court itself," Sarma told reporters on the sidelines of an official event in Bongaigaon. He said that if they cannot provide the list, they have to pay him ₹500 crore, he added.

In a post on X earlier, the CM said, "Today, I have filed a defamation case seeking ₹500 crore in damages against Congress leaders

Jitendra Singh, Bhupesh Baghel and Gaurav Gogoi for making false and defamatory allegations against me."

Addressing a joint press conference on February 4, State Congress president Gogoi had claimed that the party's "investigation" has revealed that "almost 12,000 *bighas* of land have been occupied by the CM and his family across the State".

Asked about Congress filing a police complaint in Guwahati against the BJP for circulating a controversial

video featuring him on social media, Sarma said he will continue speaking up as he has been doing now.

"It is good that they have filed the case. What does communal mean? You all know who I am against," the CM said. "What will happen to me if a case is filed? For me, white is white, black is black. They cannot frighten me. Sibani Bora, Diganta Barman, and their *malik* Rahul Gandhi can file a case against me. My thumb to them," Sarma added.

ED registers case in Tirupati *laddu* row

The Enforcement Directorate (ED) has registered a money laundering case to probe an alleged ghee adulteration scam linked to the preparation of *laddu prasadam* at the famous Tirumala temple in Andhra Pradesh's Tirupati, officials said.

The federal probe agency booked a case under the Prevention of Money Laundering Act (PMLA) sometime back to probe the alleged proceeds of crime or illicit funds generated by the accused, they said.

The ED is looking at the FIR, documents and chargesheet filed recently in the case by a CBI-led special investigation team (SIT), the officials said. The SIT has named 36 people, including nine Tirumala Tirupati Devasthanams (TTD) offi-



cials and five dairy experts, as accused in the matter.

As per the findings of the SIT, the original material which was sold to the Sri Venkateswara Swamy temple body as *ghee* was chemically processed palmolein oil and other ingredients.

The ED is looking at alleged money laundering done by the accused and possible generation of illicit funds by the accused through ghee adulteration, the officials said.

Elections are contests of ideas: Pilot

Congress national general secretary Sachin Pilot on Tuesday underlined the need for a strong opposition and healthy dialogue in a democracy, saying that the prevailing politics of confrontation and suppression were not in keeping with democratic values.

31 stone crushers in State owned by politicians, bureaucrats: J&K minister

Dr Narinder Singh Raina, a first-time BJP MLA from the RS Pura-Jammu South Assembly segment on Tuesday brought to light the names of politicians and their close relatives running stone crushers across the Union Territory of Jammu and Kashmir. Dr Raina had sought details of crusher units with political and bureaucratic links.

In response, the Deputy Chief Minister Surinder Choudhary informed the legislative Assembly that 31 stone crushers in the UT are owned directly or indirectly by politicians and bureaucrats. Choudhary, who also held the charge of the Mining department, also informed the Assembly that 48 stone crushers have been closed or sealed across nine



districts of the Union Territory for violations.

The sealing of crusher units was carried out by the District Administrations and the Jammu and Kashmir Pollution Control Committee (JKPCC), and in some cases under orders of the courts, as part of ongoing action against environmental violations and regulatory non-compliance. According to the written statement submitted in the house, these 31 stone crushers are spread

across 11 districts, and many of them are currently marked as 'functional', with a few categorised as 'seasonal'.

According to the attached list, while one stone crusher is owned by BJP MP Jugal Kishore, his brother Nand Kishore is the proprietor of another stone crusher. The name of BJP MLA from Jammu district Vikram Randhawa also figures in the list. Senior BJP MLA Sham Lal Sharma's son, Ankush Sharma, is in partnership with others in four stone crushers.

Among those in the list is Gurdeep Singh Khalsa, BJP president (Poonch district). BJP MLA Pawan Gupta's brother also figures in the list of stone crusher owners. A brother of Yougal Kr Sharma, a former minister of the Congress, owns four stone crushers. Of the 31 stone crushers, the highest number of

eight are in Jammu district, six in Kathua, four in Udhampur, four in Poonch, three in Reasi, and one each in Samba, Rajouri, Kishtwar, Ramban, Ganderbal, and Kupwara. Two stone crushers are in Kashmir. National Conference MLA from Kangan, Mian Mehran Ali, owned a crusher in Ganderbal.

Out of 48 sealed units, the Government stated that Pulwama district accounts for the highest number of units at 28, followed by Poonch with 7 and Reasi with 4 units. Two crusher units each have been sealed in Jammu, Ramban, and Udhampur, while one unit each has been closed in Kishtwar, Rajouri, and Kupwara, taking the total to 48 sealed units. However, the Government clarified that none of these sealed crusher units is presently involved in illegal mining activities, despite being closed.

Final voters' list out in Assam with 2.43 lakh names deleted from draft roll

The final voters' list was published in poll-bound Assam on Tuesday with over 2.43 lakh names deleted from the draft roll. The final electoral roll comprises nearly 1.25 crore men, 1.24 crore women and 343 third-gender voters, said officials.

At the end of claims and objections, the final roll has been published with a total of 2.49 crore voters, a decrease of 0.97 per cent from the draft roll, said a statement issued by the office of the Assam Chief Electoral Officer (CEO).

In the final list, over 2.43 lakh names were deleted from the draft roll, according to the statement.

The draft list, published on December 27 last year, had 2.52 crore enrolled voters. The Assam assembly



elections are due in April-May. A total of 2.05 per cent of names have been deleted from Chief Minister Himanta Biswa Sarma's Jalukbari constituency.

In Jalukbari, 2,06,314 electors found their names, a decline of 4,310 voters compared to the 2,10,624 listed in the draft roll published on December 27 last year, according to the press release by Kamrup Metropolitan district authorities.

Eligible voters, whose names were deleted from

the electoral rolls during the Special Revision (SR) in Assam on the grounds of having "permanently shifted", can apply for inclusion of their names, said officials. Such electors will be eligible to apply under a specific provision of the Representation of the People (RP) Act, 1950, they said.

"People who have shifted from their earlier places of residence due to various reasons, including eviction drives, will find their names deleted from their previous polling stations or constituencies. If they could not apply for shifting of their names before the deletion, they can now apply for inclusion at their new address under this provision," an official said. Applications can be filed with the final electoral roll at the end of the SR exercise being published, he added.

Jana Nayagan censor row: Producers withdraw petition in Madras HC



The Madras High Court on Tuesday permitted the producers of Tamil film *Jana Nayagan*, starring actor-turned-politician Vijay, to withdraw their petition, which sought a direction to the CBFC to grant a censor certificate to the film. Justice P T Asha, before whom the petition came up for hearing, granted permission to M/s KVN Productions LLP, producers of the movie, to withdraw the petition. The judge dismissed the petition as “withdrawn”.

The judge on January 9 allowed the petition filed by M/s KVN Productions LLP and gave a direction to the Central Board of Film Certification (CBFC) to grant a censor certificate forthwith. The judge had also quashed a communication dated January 5 of the Regional Officer, informing the producers of the film that based on a complaint, the Chairperson of the Censor Board had referred the matter to the revising committee.

Ravi Nair convicted in criminal defamation case filed by Adani Enterprises

The Magistrate court in Mansa, Gandhinagar, has convicted journalist Ravi Nair in a criminal defamation case and sentenced him to a year's imprisonment and a fine. The case followed from a complaint filed by Adani Enterprises Ltd (AEL), the Adani Group's flagship company, alleging that Ravi Nair had published and disseminated a series of tweets containing false and defamatory statements intended to damage the reputation of AEL and the Adani Group.

AEL argued that the impugned tweets did not amount to fair comment or legitimate criticism, but were designed to undermine the credibility of the company in the eyes of the public and investors. The court held that AEL had successfully established its case and found Ravi Nair guilty of criminal defamation. The court convicted Ravi Nair and imposed a sentence of one year's imprisonment along with a fine.

ED issues fresh summons to Anil Ambani, wife in money laundering case

The Enforcement Directorate has issued fresh summons to Reliance Group chairman Anil Ambani and his wife Tina Ambani to appear for questioning in a money laundering case next week, officials said on Tuesday. Tina Ambani, 68, a former actor, was asked to depose by the federal agency here on Monday but she skipped appearance.

Officials said she has now been asked to depose on February 17 followed by Anil Ambani, 66, on February 18. Their statements will be recorded under the Prevention of Money Laundering Act (PMLA) once they depose, the officials said. Anil Ambani was questioned by the ED once last year as part of these investigations linked to multiple



Reliance Group companies and their bank loans.

It is understood that Tina Ambani has been called for questioning with regard to a money trail linked to the purchase of a luxury condominium in New York's Manhattan. The ED had recently arrested former RCOM (Reliance Communication) president

Punit Garg in this case. The New York property was "fraudulently" sold in 2023 during the corporate insolvency resolution process (CIRP) of RCOM by Garg, the ED had claimed in a statement earlier. It is understood that RCOM informed the stock exchange about this "fraudulent" sale in 2025.

PM's degree: HC gives DU time to file objections to delay in filing appeal

The Delhi High Court on Tuesday granted three weeks' time to Delhi University for filing its objection to the delay in appeals against an order refusing disclosure of details of Prime Minister Narendra Modi's bachelor's degree.

Appearing for the university, Solicitor General Tushar Mehta argued that "there was nothing in the matter" and it was "only to sensationalise". He sought time to file a reply on the aspect of delay in filing the appeals challenging the single judge's order passed in August 2025, as well as on merit.



The appellants before the division bench are RTI activist Neeraj, Aam Aadmi Party leader Sanjay Singh, and advocate Mohd Irshad.

On August 25, 2025, the single judge had set aside the CIC order, saying that only because PM Modi was holding a public office, it did not render all his "personal information" to public disclosure.

It had ruled out any "implicit public interest" in the information sought, and said the RTI Act was enacted to promote transparency in Government functioning and "not to provide fodder for sensationalism".

Following an RTI application by one Neeraj, the CIC on December 21, 2016, allowed inspection of records of all students who cleared the BA exam in 1978 — the year Prime Minister Modi also passed it.

Calcutta HC rejects bail plea Kuldeep Rai in bank fraud case

The Calcutta High Court on Tuesday rejected the bail applications of former MP of Andaman and Nicobar Islands Kuldeep Rai Sharma and Sanjay Lal, another accused, in connection with a ₹500 crore bank fraud case.

The Criminal Miscellaneous case heard by a Single Bench (CRM-SB) of Justice Apurba Sinha Ray, however, granted bail to K Murugan, former managing director Andaman and Nicobar State Cooperative Bank (ANSCL), on health grounds.

Sharma, who is also the chairman of the ANSCL, and Murugan were arrested on September 17, 2025 while Lal was picked a month later by the Enforcement Directorate (ED) under the provisions of the Prevention of Money Laundering Act (PMLA), 2002.

"Upon hearing both sides at length, Justice Apurba Sinha Ray rejected bail application of ex-Andaman MP Kuldeep Rai Sharma and Sanjay Lal, while granting bail to K Murugan on health



grounds," an ED official said. "They were arrested in connection with an ANSCL fraud case of more than ₹500 Crore," the official said.

The investigation stems from an FIR registered on May 15, 2025, by the Crime & Economic Offences Cell, Andaman & Nicobar Police, against bank officials and private individuals. On July 18, the Cell arrested Sharma in connection with the case involving loan irregularities.

The arrest was made following a complaint from the deputy registrar of the cooperative societies, which alleged gross irregularities in sanctioning loans to various people by the lender.

Later, ED started a parallel investigation and conducted search operation at the Andaman and Nicobar Islands on July 31 that year.

Anchoring the Indian Ocean

Prime Minister Narendra Modi's announcement of a \$175 million special economic package for Seychelles is a timely investment

India's vision of MAHASAGAR (Mutual and Holistic Advancement for Security and Growth Across Regions) is steadily taking shape. India's growing affinity with Seychelles shows that its MAHASAGAR vision is becoming a reality on the ground. Its engagement with Seychelles reflects New Delhi's intent to be proactive in the Indian Ocean and to engage closely with its maritime neighbourhood. President Patrick Herminie's State Visit to India is more than a routine diplomatic engagement. It marks the emergence of a new synergy between the two countries. Prime Minister Narendra Modi's announcement of a \$175 million special economic package for Seychelles demonstrates how much value India assigns to the island nation. However, this is not merely a goodwill gesture; it is a calibrated investment in a partnership that is both historic and strategic. The two nations share over 50 years of uninterrupted diplomatic relations, a testament to their cooperation and smooth ties. The details of the package are noteworthy. By targeting social housing, e-mobility, vocational training, health, defence, and maritime security, India has crafted a development blueprint that balances human welfare with strategic stability. This is not simply an aid announcement; it is a statement of intent. Social housing and health infrastructure address immediate developmental needs. Vocational training creates pathways to employment. E-mobility aligns with global climate commitments. However, what makes the package particularly strategic is its emphasis on defence and maritime security. Seychelles occupies a strategic location in the western Indian Ocean. From this vantage point, it can help monitor vital global trade routes, which have gained significance due to ongoing tensions in the Gulf. In Seychelles, India has yet another partner in maritime security that can play a crucial role in safeguarding India's supply lines.

Prime Minister Modi has reiterated that India's development partnerships are guided by the "priorities and needs" of its partners. Indeed, this is a win-win situation for both countries, regardless of their size. Unlike China, India has consistently adopted a principle-based approach, earning trust and respect. For Seychelles, these targeted investments can have a transformative impact, particularly in employment generation and skill-building. The symbolism surrounding the visit adds another layer of depth. President Herminie's tribute to Mahatma Gandhi at Rajghat is deeply significant. Gandhi's principles of non-violence and cooperation resonate in India's diplomatic philosophy, especially in its engagement with the Global South. In recent years, India has positioned itself as a leading voice of the Global South and a key pillar of the Quad. India provides the Quad with its Indian Ocean anchor. With its strategic geography and naval reach, India plays a pivotal role in maintaining balance in the region.

As India positions itself as a voice for developing nations, its friendship with Seychelles demonstrates that it practises what it preaches. By combining development assistance with security cooperation, New Delhi signals that prosperity and stability are deeply intertwined.

Communication between the Modi government and the Opposition has broken down, as evidenced by the turbulent proceedings in Parliament last week. There have been no back-channel negotiations to resolve the paralysis.

The protests intensified on Monday when Lok Sabha Speaker Om Birla announced that the Leader of the Opposition, Rahul Gandhi, could not read from a magazine containing an excerpt from a book by retired General Naravane, citing parliamentary rules.

This breakdown in dialogue culminated in the Lok Sabha being adjourned for the day last Wednesday, preventing the Prime Minister from delivering his usual reply to the Motion of Thanks to the President's Address. This was unprecedented in Parliament's history: the Prime Minister was unable to speak in the Lower House on the President's Address, underscoring the seriousness of the disruptions.

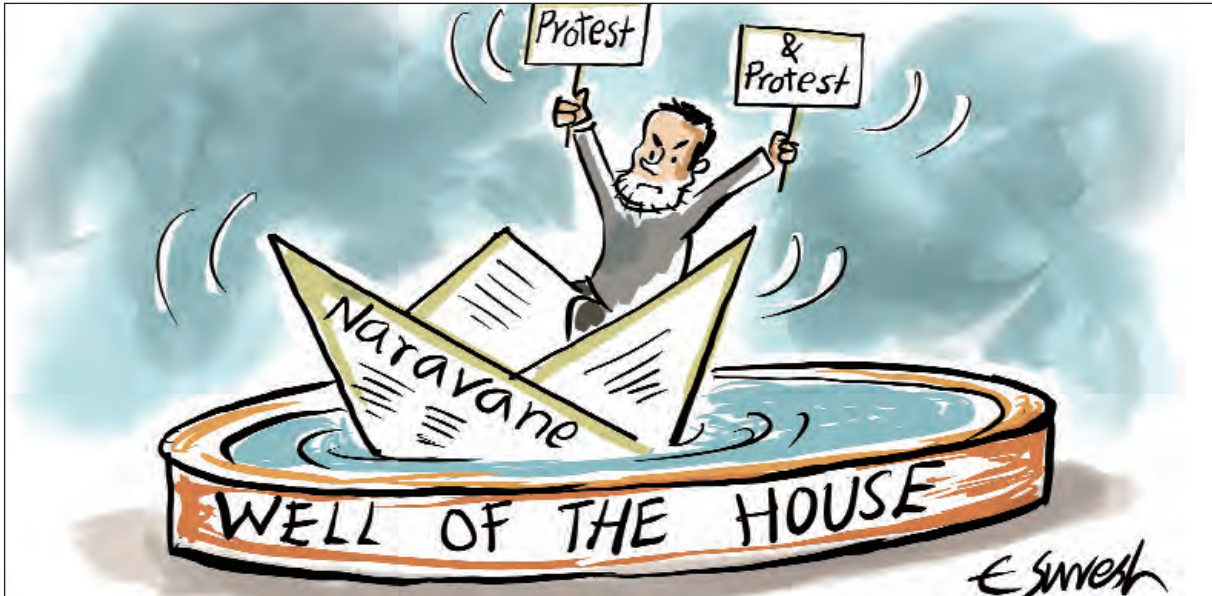
Opposition Members of Parliament from both Houses protested, especially in the Lok Sabha. These protests led to repeated adjournments of the Lower House, often just minutes after it reconvened. During the protests, members chanted slogans, entered the Well of the House, and held banners and placards in front of the Speaker. They also staged a demonstration outside Parliament.

Prime Minister Narendra Modi was unable to enter the House because Opposition women MPs had positioned themselves near his seat in the Lok Sabha.

Speaker Om Birla clarified the following day that he had advised the Prime Minister to avoid the House due to concerns about potential disruptions near his seat. He stated: "When the Prime Minister was scheduled to respond to the President's Address, I had received indications that some Congress members might attempt to create a disturbance close to the Prime Minister's chair. Such actions could undermine our democratic traditions. To prevent this, I felt it was necessary to advise the Prime Minister not to attend the House. As the presiding officer, it is my duty to safeguard these traditions."

Women Members of Parliament obstructed the aisle near the Prime Minister's seat just before his arrival, highlighting the active role of Opposition women MPs in the disruptions.

In a related development, Rahul Gandhi commented on a memoir by a retired Army

chief that has yet to be released. The memoir, written by General Naravane in March 2023, is slated for publication in December. General Naravane has been widely recognised for his integrity.

Overall, Parliament faced significant disruption due to repeated adjournments. This turmoil highlights the challenges of maintaining parliamentary decorum and the importance of respectful debate for effective governance. In earlier years, there were several high-quality debates.

The following day, the Prime Minister spoke extensively in the Rajya Sabha about his government's achievements and various initiatives it had launched. He addressed India's position in global affairs and its increasing influence on the world stage. The Prime Minister praised his 11 years in office while strongly criticising the Nehru-Gandhi family for their failure to develop the country effectively. The speech resembled an election rally, filled with punchlines.

Members of Parliament often create disturbances to protest and gain media attention. Their actions include rushing to the Well of the House, shouting slogans, holding up signs, and at times even tearing up Bills. This behaviour reflects deep political divisions and a shift towards confrontational politics.

There has been a noticeable increase in time lost to disruptions, as well as in the costs of running Parliament. It costs approximately ₹2.5 lakh per minute, ₹1.5 crore per hour, and ₹9 crore per day of taxpayers' money, highlighting the financial impact of these disruptions on public resources.

According to NDTV, losses continue to mount even when the Houses are adjourned, with expenses including the operational

costs of the high-tech Parliament building, staff salaries, and expenditure on security, among others.

Disruptions in Parliament not only hinder government accountability and limit meaningful discussion but also delay the passage of crucial legislation, affecting public welfare and policy implementation. This underscores the urgent need for reform.

Many committees have recommended reforms for Parliament and have emphasised the need for positive change and support for necessary improvements. In a parliamentary democracy, frequent disruptions not only hinder legislative progress but also erode public trust and weaken democratic legitimacy.

To address this, electoral reforms are needed to improve the quality of elected representatives. Greater understanding among political parties should also be encouraged, using both formal and informal mechanisms. By increasing public awareness of Parliament's role and how disruptions harm the public interest, these disturbances can be reduced.

Parliamentary standing committees, such as those in the UK and Canada, have successfully mediated conflicts and improved decorum through structured dialogue and conflict resolution. Such examples can inspire support for similar reforms and demonstrate their effectiveness in strengthening parliamentary functioning.

These reforms should be implemented sooner rather than later, with political cooperation playing a crucial role in restoring faith and ensuring the smooth functioning of Parliament. Above all, strong political will is required.

When taxes start feeling like a punishment

The moment the word taxes enters a conversation, shoulders slump. Faces tighten. For many Indians today, taxes no longer feel like a civic duty; they feel like a quiet penalty for choosing to earn honestly in this country.

The irony is painful. An entire year is spent working relentlessly — long hours, skipped family dinners, postponed holidays, and strained mental health. We plan our finances carefully, invest where we can, and chase stability in an economy where inflation quietly eats into every salary slip. And then, almost ceremoniously, a portion of that hard-earned income is taken away.

Professional tax is deducted without question. Income tax follows if your salary crosses the ₹12 lakh threshold. For someone earning ₹13-14 lakh annually, the income tax outgo can equal nearly a full month's salary. One

month of work — gone. Not spent. Not saved. Simply surrendered.

This would not sting as much if incomes were rising faster than costs. But they are not. Inflation has turned everyday living into a careful calculation — rent, school fees, healthcare, fuel, groceries. Savings are already stretched thin. So when taxes take away what could have been a safety net, the feeling is not anger alone. It is anxiety. It is fear. It is exhaustion.

We grow up being taught a beautiful lesson: give without expectation. Give and forget. Charity, generosity, *seva* — these values are deeply Indian. But taxes do not feel like charity. They feel compulsory. And unlike voluntary giving, they refuse to be forgotten, because their absence is felt every month, in every compromised plan.

Some well-meaning people say, "Treat taxes like a donation to the government." That sounds noble - but donations work on trust, visibility, and certainty. When we donate to a cause, we know where the money is going. We see the school built, the child educated, the hospital equipped. Taxes, on the other hand, disappear into abstraction.

Research consistently shows that tax morale - people's willingness to pay taxes — increases when governments communicate clearly about how tax money is used. Countries that publicly link taxes to healthcare systems,

transport infrastructure, education, and social security see higher compliance and lower resentment. Transparency builds trust. Uncertainty breeds resistance.

In India, the average taxpayer often feels invisible. The benefits of taxation feel distant, uneven, or inaccessible. Roads remain broken, public hospitals overcrowded, and middle-class families continue to self-fund education, healthcare, and retirement — despite paying substantial taxes. This disconnect is where resentment grows.

People are not unwilling to contribute. Indians donate generously, volunteer tirelessly, and support communities instinctively. What they resist is paying without knowing. Giving without seeing impact. Sacrificing without assurance. If taxpayers were clearly shown — this portion funded rural healthcare, this built urban infrastructure, this supported education — many would pay with pride, not pain. Accountability would transform taxes from a burden into participation.

Until then, taxes will continue to feel less like nation-building and more like a survival negotiation. And the question will linger in every honest earner's mind: Why does earning more feel like losing more?

Bridging gender gap in Science

International Day of Women and Girls in Science, observed on 11 February, highlights the need for inclusive scientific progress. Science and technology for sustainable development, along with women's empowerment, are critical for national growth. Yet women and girls continue to lag behind their male counterparts in India's research ecosystem in terms of participation, though not in quality.

Studies in STEM subjects — science, technology, engineering and mathematics — show that girls become increasingly under-represented as they advance in their education and careers. Less than 30 per cent of technology researchers are women. The aptitude exists; what is often missing is sustained support.

Gender inequality, career breaks, workplace bias, and inadequate institutional support prevent many talented women from reaching leadership roles. Employers must adopt more flexible recruitment, retention, and remuneration policies. A worker-friendly environment, supportive of work-life balance, is the strongest incentive. If nurtured, women's scientific potential can significantly strengthen India's innovation and development landscape.

Banks must curb digital fraud

The Supreme Court's call for a standard operating procedure to protect victims of digital fraud is timely. Reports of senior citizens losing their life savings to cybercriminals are increasing at an alarming rate. Coerced transfers and online scams are leaving victims financially and emotionally devastated.

Banks already require prior intimation for cheque payments above a threshold. Similar safeguards can be applied to online transactions, with customer consent. Most Indian banks use AI to detect unusual high-value transactions that deviate from account history; this system should trigger temporary holds and mandatory verification.

For joint accounts, banks should confirm such transfers with all account holders. Customers could also opt for a protective hold that requires in-person verification before large transfers are processed.

When a new beneficiary is added, a mandatory cooling-off period of at least 24 hours should be enforced. Banks could cross-check beneficiaries against an RBI-maintained database of mule accounts and suspicious entities. Ultimately, sustained public awareness campaigns against digital fraud are essential to reduce vulnerability.

Parliamentary norms face erosion

The adoption of the Motion of Thanks to the President's Address in the Lok Sabha without the Prime Minister's reply marks a troubling break from parliamentary convention.

The Speaker's explanation — that security concerns warranted the Prime Minister's absence — sets an uneasy precedent. Parliament must remain a forum for debate, not suspicion.

Equally concerning was the refusal to allow the Leader of the Opposition to cite excerpts from a former Army Chief's book, despite his willingness to authenticate them. Restricting discussion on issues of national importance weakens democratic oversight.

The Motion of Thanks debate is a constitutional mechanism through which the executive is held accountable. Bypassing the Prime Minister's reply without formal resolution undermines both procedure and principle. Increasing disruptions and mistrust are replacing reasoned debate.

Invoking security threats to limit parliamentary speech risks eroding faith in democratic institutions. The nation's highest law-making body must function with dignity, transparency, and adherence to established norms.

GOLD AND SILVER STRUGGLE TO HOLD HISTORIC GAINS

Precious metals began 2026 on a strong note, with both gold and silver reaching fresh record highs in January. However, recent trading sessions have seen sharp volatility, with prices cooling by nearly 10 per cent from their peaks. Gold and silver traditionally move in tandem, and many investors still consider gold a lifetime store of value. Prices fluctuate according to market trends, and falling rates often stimulate renewed buying interest in bullion markets.

The current turbulence follows an extended rally, prompting experts to advise close monitoring of daily price movements before making investment decisions. As of February 2026, silver fell by 12 per cent in a single session after touching record highs, while

gold also experienced wide swings amid rising margin requirements and geopolitical tensions. Markets are responding to high-level Iran-US discussions in Oman and speculation over potential changes in Federal Reserve leadership.

Despite recent corrections, both metals have recorded strong gains in recent years, with silver rising over 225 per cent and gold nearly 88 per cent in the past two years.

Volatility in gold is at levels not seen since the 2008 financial crisis, while silver's turbulence echoes conditions last witnessed in 1980, highlighting the uncertain outlook for precious metal investors.

The Epstein mirror: How power and money colluded in plain sight

In Epstein's cold abstractions — where harm dissolves into systems and money washes away its origins — we glimpse a deeper, more unsettling truth: the architecture of Western power did not merely tolerate him; it understood him, and often found him useful



It is ugly. It is disgusting. No one knows whether he died by suicide or by some other, more carefully arranged ending, designed to bury what he knew and whom it protected. But this is what the hypocritical West looks like when the curtain slips. You praise a person as long as you do not know what sits inside him; you despise him the moment the rot begins to breathe in public. Jeffrey Epstein tells a complete story of what America and the West have become, not because he was exceptional, but because he was ordinary in the ways that matter most. From Chomsky to Bill Gates, Elon Musk to Trump, from New York boardrooms to Westminster salons, and the long, awkward associations with figures such as Peter Mandelson, the same putrid pattern repeats. This is not about monsters hiding in basements. This is about appetite, denial, and the theatre of respectability.

Last week, as millions of pages from the so-called Epstein files began circulating again, another artefact surfaced alongside them: the last known interview Epstein ever gave, recorded with Steve Bannon. It is not a confession. It is not remorseful. It is something far colder. A man speaking as if the trial were civilisation itself, not him.

He speaks of finance as something closer to mysticism than economics. Leaders, he suggests, do not understand the systems they claim to govern. "You weigh and measure every day," Bannon tells him. "You weigh and measure people. You weigh and measure leaders. You weigh and measure economies." Epstein replies, calmly, "I don't even know what it means to be measured." Not as evasion, but as assertion. Measurement, in his account, is approximation, an abuse of language, a crude imposition on reality. Precision itself becomes a fiction.

He repeatedly returns to this refusal. Asked when human life begins, he says the question itself is malformed. "You're asking me to measure something again." Pressed further, he retreats into paradox, invoking Zeno, quantum behaviour, and the impos-

sibility of exactitude. Hair, skull, height, decimals. The question dissolves into semantics. Nothing lands. Nothing sticks. This is the rhythm of the interview. Whenever responsibility approaches, the language lifts off the ground.

Epstein frames history as a long record of misunderstanding. Newton, he says, could describe motion but not explain it. Quantum physics only widened the mystery. "We just cannot explain," he repeats. Electrons are not things but clouds. Solids are not solid. At small scales, reality collapses into probabilities. From this, he draws a broader claim: that science, mathematics, and formal systems are the wrong tools for understanding life. "No really new ideas have come out," he says of modern institutions, because they are trapped using the wrong instruments.

He applies this logic everywhere. Markets are not calculable; they are felt. Traders succeed through intuition, not models. Mathematics follows action, never the reverse. Measurement arrives after the fact, to justify what instinct already decided. Crises are not moral failures; they are structural inevitabilities. Collapse is not crime. It is mechanics.

Rockefeller and JP Morgan appear in his telling as honest predators, men who never pretended capitalism was humane. Modern leaders, by contrast, are described as symbolic figures, trapped inside systems they cannot read, repeating language about growth and stability while liquidity moves independently of them. Whether this is true is almost irrelevant. What matters is that Epstein speaks as if

proximity to power grants ontological superiority. Understanding, in his world, is not earned; it is inherited through access.

The files released alongside this interview make the same argument without words. Names recur. Flights recur. Dinners recur. Foundations recur. What disappears is responsibility. Everything is coincidence. Everyone was only passing through. The documents do not need to prove every allegation to expose the structure. Power does not operate through direct orders. It circulates. It accumulates. It protects itself through diffusion.

When Bannon asks whether institutions should take money from someone like him, Epstein does not deny the question's legitimacy. He reframes it. He speaks of polio vaccines in Pakistan and India. He asks whether mothers would refuse money if told it came from the devil himself. "I don't care, I want the money for my children," he imagines them saying. Utility overrides origin. Outcome erases source. Pressed further, Bannon asks the question directly: is your money dirty money? Epstein answers simply: no. He earned it — advising terrible people, perhaps, but earning it nonetheless. Ethics, he suggests, are always complicated. This is not a defence. It is a declaration of how the world works.

At one point, Bannon asks whether Epstein thinks he is the devil. Epstein does not laugh. He deflects. The devil, he says, scares him. Satan, he notes, was brilliant, an archangel who rebelled because he

could not be number one. The comparison lingers without resolution. The interview ends shortly after. No absolution. No reckoning.

What emerges from this last interview is not a man in denial, but a man entirely comfortable with abstraction. Shame is translated into systems. Harm dissolves into theory. Victims never appear as subjects, only as variables implied offstage. Consciousness, intuition, the soul all enter the conversation only to establish that nothing essential can be pinned down.

The files show how well this posture was accommodated. Universities accepted money while insisting they were neutral. Politicians appeared alongside him while assuring themselves they were merely polite. Media figures attended dinners while calling it observation. Everyone performed a role and trusted that performance itself was protection.

The West likes to describe itself as transparent, but it survives through selective blindness. Confession is demanded from the weak. Silence is granted to the useful. When scandals erupt, they are framed as deviations rather than products. Epstein's story is intolerable precisely because it refuses that comfort. He does not apologise for understanding the rules as they are practised rather than preached.

There is an instinct to personalise the horror, to catalogue names and savour disgrace. That instinct misses the deeper point. Epstein's circle was not united by

ideology or loyalty, but by convenience. People who would never share a moral code shared aircraft. People who condemned exploitation in public tolerated it in private. This is not casual hypocrisy. It is structural compartmentalisation.

The West has learned to split its self-image from its conduct, to celebrate progress while outsourcing its costs to the unseen. Epstein did not disrupt this order. He navigated it fluently. Financier, philanthropist, intellectual — he shifted registers with ease. The files show how often this worked.

His death resolved nothing. It converted a living problem into an archival one. Documents replaced testimony. Speculation replaced trial. The anger dispersed into procedural arguments. Meanwhile, the structures that enabled him remain untouched: reverence for wealth, fear of disruption, and the confusion of success with legitimacy.

What makes the interview disturbing is not bravado. It is tone. Epstein speaks without urgency, without fear, as if describing weather patterns. Consequences are acknowledged but not absorbed. Effects are catalogued without weight. In another setting, this might be called rational detachment. Here, it reads as something closer to anaesthesia.

The West will move on. It always does. New crises will arrive. New villains will be named. Epstein will become shorthand, a symbol stripped of texture. But the interview and the files resist that reduction. They insist on something more uncomfortable: that the conditions which allowed him to exist were not aberrations, but habits. If there is value in revisiting this material, it lies in resisting the urge to externalise evil. Epstein was not an alien intrusion. He was cultivated by institutions that prized outcomes over methods, by cultures that mistook access for insight, and by elites who confused proximity with virtue. His story is not a warning about one man. It is a mirror.

Franz Kafka understood that once life becomes performance, sincerity becomes dangerous. Masks protect, but they also suffocate. The Epstein saga shows what happens when a civilisation forgets how to remove them. The disgust now surfacing is not directed only at him. It is the nausea of recognition — the awareness that the distance between what is condemned and what is tolerated was never very wide at all.

Congress dilemma: Why Rahul Gandhi must decide the Party's future now



Two decades in politics is not a small period. Though the learning curve never ceases to exist, the time comes in the life of a political leader to give a real account of himself or herself and accordingly take tough decisions. Such a situation cannot be allowed to linger on forever in view of the dynamically changing political landscape.

Ironically, after two decades of active politics and, in between, an unsuccessful bid for the presidency of India's oldest political party, the Indian National Congress, Mr Rahul Gandhi still finds himself at a crossroads. Which way to go and which road to take — he seems to be stuck in a dilemma.

He has allowed himself to become the de facto chief of the party, and at the same time his close aides take pains to deflect this perception by painstakingly reminding the country that Mr Mallikarjun Kharge is the fully elected president of the party. There is no denying this fact, but ground realities point in a different direction.

Mr Kharge has been Congress president for over three years after defeating Mr Shashi Tharoor, with the full support of Mr Gandhi and his family. Everyone knows that Mr Kharge's candidature was openly backed by Mrs Sonia Gandhi, which set the course for the poll outcome. Ever since, Mr Tharoor, being suspect in the eyes of Gandhi-camp backers, has acquired the status of a rebel, while Mr Gandhi remains the de facto boss calling the shots.

Whatever Mr Gandhi did during the last three years (Mr Kharge's tenure) naturally has his stamp, and whatever he did not do also bears his stamp. The "not doing" part pertains to indecisiveness — be it taking over the mantle as Congress president, bringing far-reaching organisational changes, or implementing his own words expressed from time to time. He must take equal credit or blame for decisions taken or not taken.

Solo acts without the backing of a solid organisation will not take you very far, Mr Gandhi. Nor will closing your eyes to rejuvenating the Congress.

This prolonged paradox has now begun manifesting dangerously and is desperately awaiting a rescue act. On the contrary, the situation has become more serious, with the positive impact generated by Mr Gandhi's strenuous Bharat Jodo Yatra (BJYs) almost on the verge of evaporation. In the absence of a follow-up plan, and with



deeply divided party units from the AICC down to the states and Union Territories failing to effectively take Mr Gandhi's message to the grassroots level, the historic event is slipping into oblivion.

The BJP's sleeper cells are merrily running PCCs in many states and UTs.

If this reflects Mr Gandhi's shortcomings, it is also an abject failure of his support team, who work in close proximity to him, either in sustaining on the ground the aftermath of such gigantic programmes or in tendering impactful advice to him. The oft-repeated complaint in AICC circles, and a question frequently asked in public, is: "Who are Mr Gandhi's advisers?" No one knows the answer.

Yet another common refrain is the inaccessibility of him and his AICC team, particularly the general secretary (organisation), Mr KC Venugopal, to party leaders and the rank and file — let alone the public at large. This is a jarring situation, which none other than Mr Gandhi himself can tackle. He has to set a new model, through personal example, to be followed by others down below. He has a multifaceted personality with a strong knowledge base, but most of the time he misses the point that being a leading political light entails leading from the front through personal example.

His fight for the marginalised sections of society is commendable, and it has been his quest to bring the core support base back to the Congress. A missing balanced approach — caring for all and antagonising none — has led to this quest creating a buzz but not accruing any electoral benefits. This is something Mr Gandhi must sit and mull over.

The political situation in the country is dynamic and changing fast, with serious questions being raised about the thinking, policies, and planning of the Narendra Modi government — more importantly, about its handling of the social fabric of society.

The unfortunate episode involving Swami

Avimukteshwarananda ji, Shankaracharya of Jyotish Peeth, at the Prayagraj Magh Mela — where he sat on dharna protesting against alleged insult by the administration, with no word of pacification coming either from Prime Minister Mr Modi or UP Chief Minister Yogi Adityanath — has added new grist to the political whirlwind. This is a serious development which Congress cannot ignore, particularly in the face of the aggressive Hindutva agenda of Mr Modi and the Shankaracharya questioning its veracity.

Unfortunately, the Congress does not seem prepared to act in consonance, or preferably remain a step ahead of the situation, amid these fast-paced developments. In contrast, the BJP and the Modi government's fire-fighting techniques are ever ready, rediscovering ways at a fast pace to repeatedly turn the tables.

The Congress and Mr Gandhi must shun lethargy if he is to remain in the game. There are misdemeanours of the ruling dispensation, such as the Special Intensive Revision (SIR) of the electoral rolls and various other measures that tilt the balance in its favour, thereby preventing a level playing field. Mr Gandhi's fight on this front is laudable, but nothing will succeed without setting his own house in order. He cannot be seen as fighting as a loner, but as a leader heading a strong pack, which he must develop steadily.

Firstly, he must clear his mind on whether he wishes to perpetuate the current de facto model of Congress leadership, intends to lead from the front, or is prepared to give a chance to someone else. In any situation, decision-making should not become a casualty. It is because of indecisiveness and opaqueness in the AICC's functioning that things have worsened by the day.

Someone might say that even Mr Modi is far removed from the BJP's rank and file, yet his graph has been rising for the past decade. The strong organisational system, backup support, and capacity to take hard decisions make the difference in his case. There is a multi-tier mechanism in the saffron party's organisational setup which keeps both Mr Modi and his party going through all seasons.

An opposition leader like Mr Gandhi, who is continuously under the scanner of his political opponents, cannot afford the luxury of remaining oblivious to emerging situations or the challenges with which his own party has been beset. There is a strong case for transition and generational change, which he ostensibly wishes to pursue. It requires courage, conviction, fortitude, flexibility, and, at the same time, the will to take strong decisions.

India's march towards becoming a technology superpower in the domains of electric vehicles, defence systems, energy grids, space and science critically depends on rare metals which most people have never heard of. These are the 17 rare earth elements that make or mar any country's achievements in the technology sector.

India is not short of them. From Odisha's beach sands to the coastal stretches of Tamil Nadu and Kerala, the country holds around 6 to 7 per cent of the world's rare earth reserves. Yet it contributes barely 2 per cent of global output. The problem is not below the soil, but above it — the near absence of policy, foresight, and perhaps the inability to match China's mining and exploration economics.

China controls nearly two-thirds of the world's production and almost 90 per cent of its refining facilities. Even ores mined in the US or Australia are often sent to China for processing. This dominance gives Beijing quiet but immense leverage — the ability to decide who gets to build the next generation of technology.

India's monazite-rich sands are managed largely by Indian Rare Earths Limited (IREL) under the Department of Atomic Energy, but for decades private mining was restricted due to nuclear sensitivity concerns. While China built a massive ecosystem of mines, magnets and finished electronics, India kept its resources idle or exported raw sand.

The result is a form of strategic dependence that undermines India's technological sovereignty. Without rare earths, no electric vehicle motors, wind turbines, advanced radars, or smartphones can exist.

China's rare earth offer to India unsettles Washington

India's recent drive towards rare earth self-reliance has gathered quiet momentum. The government has rolled out new incentives to attract domestic refining and magnet manufacturing, while strengthening the Indian Rare Earths Limited network to handle processing locally.

This shift comes as China, the world's dominant rare earth supplier, has made a calculated move — offering to resume limited supplies to India on the condition that the mate-



rials are not re-exported to any third country. The unspoken reference is to the United States, which has been struggling to secure its own non-Chinese supply chains.

China's conditional offer to India emerged just as US officials were pressing allies to diversify rare earth sourcing away from Chinese control. Beijing's signal that India could buy only for its own consumption — not as a back door for American industries — most likely angered Trump, who imposed even higher tariffs on China. What began as a trade war over steel and semiconductors has thus extended into a strategic contest over the raw minerals that underpin modern technology. India is now caught between opportunity and caution, wary of being drawn into the rivalries of its two biggest trading partners.

India's problem is not geological scarcity but the lack of refining and processing capability. Even if India mined aggressively, the ores would still have to be sent abroad for separation — mostly to China. That is where the true choke point lies.

To break out, India needs a national rare earth mission: open mining to private investment under strict safeguards, establish domestic refining clusters, and link universities and defence laboratories for downstream innovation. Until India can turn its rare sands into strategic strength, it will continue to build on borrowed elements.

As Sam Altman's OpenAI experiments with advertising in ChatGPT, its fiercest competitor, Anthropic (with Claude's AI tool) mocked the former, and released a long blog to explain why advertising has no place in AI. In this column, we reproduce the blog:

There are many good places for advertising. A conversation with Claude is not one of them. Advertising drives competition, helps people discover new products, and allows services like email and social media to be offered for free. We have run our own ad campaigns, and our AI models have, in turn, helped many of our customers in the advertising industry. But including ads in conversations with Claude would be incompatible with what we want Claude to be a genuinely helpful assistant for work, and for deep thinking. We want Claude to act unambiguously in our users' interests. So, we have made a choice: Claude will remain ad-free. Our users will not see 'sponsored' links adjacent to their conversations with Claude; nor will Claude's responses be influenced by advertisers, or include third-party product placements our users did not ask for.

When people use search engines or social media, they have come to expect a mixture of organic and sponsored content. Filtering signals from noise is part of the interaction. Conversations with AI assistants are meaningfully different. The format is open-ended; users often share context, and reveal more than they would in a search query. This openness is part of what makes conversations with AI valuable, but it is also what makes them susceptible to influence in ways that other digital products are not. Our analysis of conversations with Claude (conducted in a way that keeps all data private and anonymous) shows that an appreciable portion involve topics that are sensitive or deeply personal, the kinds of conversations you might have with a trusted advisor. Many other uses involve complex software engineering tasks, deep work, or thinking through difficult problems. The appearance of ads in these contexts would feel incongruous and, in many cases, inappropriate.

We still have much to learn about the impact of AI models on the people who use them. Early research suggests both benefits, like people finding support they could not access elsewhere, and risks, including the potential for models to reinforce harmful beliefs in vulnerable users. Introducing advertising incentives at this stage would add another level of complexity. Our understanding of how models translate the goals we set them into specific behaviours is still developing; an ad-based system could therefore have unpredictable results. Being genuinely helpful is one of the core principles of Claude's Constitution, the document that describes our vision for Claude's character, and guides how we train the model. An advertising-based business model would introduce incentives that could work against this principle.

Consider a concrete example. A user mentions they are having trouble sleeping. An assistant without advertising incentives would explore the various potential causes, stress, environment, habits and so on, based on what might be most insightful to the user. An ad-supported assistant has an additional consideration: whether the conversation presents an opportunity to make a transaction. These objectives may often align, but not always. And, unlike a list of search results, ads that influence a model's responses may make it difficult to tell whether a given recommendation comes with a commercial motive or not. Users should not have to second-guess whether AI is genuinely helping them or subtly steering the conversation towards something monetisable. Even ads that do not directly influence an AI model's responses, and instead appear separately within the chat window would compromise what we want Claude to be: a clear space to think and work. Such ads would also introduce an incentive to optimise for engagement, (or) for the amount of time people spend using Claude, and how often they return. These metrics are not necessarily aligned with being genuinely helpful.

The most useful AI interaction might be a short one, or one that resolves the user's request without prompting further conversation. We recognise that not all advertising implementations are equivalent. More transparent or opt-in approaches, where users explicitly choose to see sponsored content, might avoid some of the concerns outlined above. But the history of ad-supported products suggests that advertising incentives, once introduced, tend to expand over time as they become integrated into revenue targets, and product development, blurring boundaries that were once more clear-cut. We have chosen not to introduce these dynamics into Claude.

Anthropic is focused on businesses. Developers, and helping our users flourish. Our business model is straightforward: we generate revenue through enterprise contracts, and paid subscriptions, and we reinvest that revenue into improving Claude for our users. This is a choice with tradeoffs, and we respect that other AI companies might reasonably reach different conclusions. Expanding access to Claude is central to our public benefit mission, and we want to do it without selling our users' attention or data to advertisers. To that end, we have brought AI tools, and training to educators in over 60 countries, begun rational AI-education pilots with multiple governments, and made Claude available for non-profits at a significant discount.... Should we need to revisit this approach we will be transparent about our reasons for doing so.

Gen Z's study flight, home landing

Two-thirds want to go abroad; one in eight will work overseas

Recently, Commerce Minister Piyush Goyal said that India did not talk about H-1B visa concerns with the US as it finalised the bilateral trade framework. He cited the main reason as the lack of interest among the IT firms to send techies abroad. Looking at the same problem from the potential employees' perspective, a recent survey finds that most of Gen Z's desire to go abroad to study, although a lower percentage wishes to work there. Maybe Goyal is on the right track. Like Indian firms, Indian job seekers have lost interest in overseas jobs.

A recent Snapchat survey among Gen Z, which was conducted in partnership with a media firm, finds that the young cohort views education as "an investment that unlocks options rather than as a fixed pathway." Career, for them, is "marked by flexibility and continuous upgrading." More than three-fourths of the respondents hope to pursue higher education, and more than two-thirds of the total want to study abroad. Hence, better education, especially abroad, is crucial. Hence, if the doors and windows to the American universities are shut, or partially closed due to the ongoing visa controversies, they will need to seek new options, maybe to Europe, Australia, or Asian colleges.

But there is a dramatic change when it comes to careers. Despite the craving for overseas education, Gen Z does not want to work overseas. A mere 13 per cent of the respondents wanted jobs away from India. Nearly half of them wanted to work in India, 28 per cent in the private sector, and 21 per cent in government or public sector. A quarter of them wished to become Indian entrepreneurs, possibly because of the opportunities related to ideas and innovation, wealth creation, and financial and other official benefits. Despite the myth that they fixed jobs,

only 10 per cent want "creative or freelance" careers.

Yet, Gen Z desires work flexibility. Even in corporate jobs, they do not want fixed 9-to-5 hours. More than a third of the respondents were for hybrid models (a mix of work-from-office, and work-from-home), and another 17 per cent wanted only work-from-home options. Since 13 per cent wanted to be entrepreneurs, and nine per cent preferred field jobs, just over a quarter of the respondents wanted to be present in offices for 8-12 hours. Given this mix, it is logical that salary, which is largely a consequence of being in offices, is a motivator for just over a third of the respondents. Other factors such as work-life balance (24 per cent), security (17 per cent), and passion (15 per cent) are crucial.

The seemingly-tech obsessed younger people use the new tools in myriad ways. Artificial Intelligence (AI), for example, acts more like a "practical assistant" in areas such as study, work, and problem-solving. Tech does not lead these young people. Instead, they are a step ahead of tech, and decide how and when to use the AI tools. "I do not use ChatGPT to write my content. But I use it extensively to do my research, and give me some insights, which I can incorporate," says a young 24-year-old budding journalist-writer. The same is true in other professions, where they understand the limits of AI.

Similarly, the use of tech in daily non-professional lives is functional. Two-thirds of the respondents agreed that AR tools help them to "understand products better than regular images or videos." More than 60 per cent believe that AR-based demos for products are more "believable and trustworthy." Thus, augmented reality

is almost a substitute for reality, rather than traditional 3-D models. In social media, which is the place to generally express themselves, Gen Z uses AR to create content that is unique, and nearly 60 per cent prefer such content compared to static photographs, even videos. AR, most feel, helps them to express their online personalities better.

Personalities and identities reflect in other areas. Brands become important to Gen Z only if they feel personal, and have meanings that are relevant to the individuals. Savvy, polished, and finessed advertising does not work. This may imply critical messages to the advertisers. Single and uniform messaging may not work with this cohort. Even regional,

and community may prove to be relevant. What is required, perhaps, are messages that appeal to individuals, and their friends, families, and social media acquaintances. Hence, Gen Z work and respond in closed groups that are smaller and more personal-oriented. Thus, social media groups may be a better advertising option.

As a report in the media that partnered with Snapchat states, "The 2025 data highlight a clear decision framework. Desi brands evoke pride. Products must 'vibe' with personal values. Purchases are made only if they offer clear value for money. Safe spaces are defined by inner circles rather than public platforms. Mutual wellness is seen as essential, not optional. Wealth creation is a long-term focus, while technology is used for efficiency, not just for visibility." In essence, most values associated with decisions are related to personality, closed-group, specific values, and the so-called inner circles.

Logically, this mindset seeps into the emotional arena. Gen Z can discuss sensitive issues like mental health but within trusted circles. Intimate and intense support system is crucial. While one can talk about views, ideas, and opinions on social media platforms, personal conversations like daily life updates are reserved for close friends, and family. But there is openness within these closed systems. More than 70 per cent discuss mental health openly. Nearly 80 per cent share life updates. Yet, bizarrely, nearly 90 per cent give or get opinions on social media, and 64 per cent talk about personal lives there.

Like with brands, shopping follows the same paradigm. As the media report stated, "93 per cent research both offline and online to find the best deals. 87 per cent buy brands that have personal meaning. 84 per cent follow influencers who share real, authentic feelings. 79 per cent are open to buy niche or less-known products. 88 per cent take pride in buying Indian-origin brands. 79 per cent trust influencers who look and talk like them." In a way, Gen Z is not about us versus them, or our generation versus others. It is more about 'us' within a small, intimate, trusted, and close group that shares and talks. As some of them maintain, "Deal hunting is a lifestyle. I just do not buy names, I buy meaning. If it feels like me, it wins. Only real influencers matter."

Initial excitement and gains may lead to fatigue and burnouts

that might previously have justified additional help or headcount." Suddenly, people took on semi-formal and informal work, which was not a part of their responsibilities. This is akin to the Gen Z feeling of 'I do because I can.' Employees did more, went beyond their calling because it was easy.

Over time, as expected, the trends blurred the boundaries between work and non-work. Since the initial assimilation of extra work was easy and simple, as well as faster, "workers slipped small amounts of work into moments that had previously been breaks." It was logical for them to prompt AI tools during lunchtimes, and coffee breaks, or during conversations with colleagues. Indeed, many admitted that they would send a "quick last prompt" before they left the office so that AI could keep working overnight while they were at home.

This enabled them to come in the mornings, and start work straight away on a problem or issue. It did not feel like extra work. In fact, AI was filling in the hours when the employee was not at work. But the result was a typical workday when the employee spent more time at work. Although it started as chatting with AI, work spilled into late evenings.

Finally, the extra use of AI, which was fun and exciting earlier, as well as empowering and satisfying, translated into a new work rhythm that typified, and accelerated the art and science of multi-tasking. Now, the employee seems to work with a tech partner, who was helpful, non-complaining, and ever-ready to share the work burden. Since two people, a real and virtual one, were at work, they could do several tasks at the same time. "While this sense of having a 'partner' enabled a feeling

of momentum, the reality was a continual switching of attention, frequent checking of AI outputs, and a growing number of open tasks," states the study. Hence, over time, the new rhythm "raised expectations for speed, not necessarily through explicit demands, but through what became visible and normalised in everyday work." In the end, the employees felt the pressures, and found that their workloads were higher, although AI use was supposed to achieve the opposite.

Logically, the workers felt busier than before after a period. One of the engineers, who worked for the firm, said, "You had thought that maybe, oh, because you could be more productive with AI, then you save some time, you can work less. But then really, you do not work less. You just work the same amount, or even more." Firms may see this scenario as a win-win-win, for which manager does not like voluntary initiative on the part of the employees to work harder, and put in more hours. In today's corporate jungle, working more hours is ideal. In the case of AI, the delivery was implicit. This was a productivity explosion at its best. The employees seem to be caught in work warp, and trap, and that too without a human prompt. The employers got the best of the AI bargain without a major push. Tech offered what it needed to.

"But our research reveals the risks of letting work informally expand, and accelerate: What looks like higher productivity in the short run can mask silent workload creep, and growing cognitive strain as employees juggle multiple AI-enabled workflows," concludes the study. In fact, overwork can impair judgments, increase errors, and make it harder to differentiate genuine gains from unsustainable intensity. The firms' expectations rise, even as the employees feel the brunt of burnouts and fatigue, with almost no way to step away. Firms plug away with the higher use of AI, nestled in the comforts of the visible benefits, and employees seek ways, mostly in vain, to find their earlier rhythm. In the end, the employees' fall on the steep downward slope is followed by the firm's similar trajectory, which may come with a lag. AI, which pushes both to a new high, pulls them down to unbelievable lows. The trend is one-way, upwards, and downwards, with no choices and options.

How India’s new CPI will measure inflation in a changing economy

What affects us daily is not India’s foreign policy or its defence preparedness; it is the price of everyday goods that one needs to carry home to survive and lead a happy, healthy life. The way the rise in the market affects all of us is measured by the Consumer Price Index, or CPI, which measures the price rise and fall — inflation, to be technical. It is one index that decides the performance of the Government and its prospects in the coming elections. That is why the importance of CPI cannot be overstated. It normally gets a new base year every ten years, but this time it is around 12 years, as it could not be done due to the Corona pandemic.

The Ministry of Statistics and Programme Implementation (MoSPI) is all geared up to shift the base year from 2012 to 2024. This revision will redefine how inflation is captured in a rapidly digitising, services-heavy, and urbanising economy. As Saurabh Garg,

Secretary, Ministry of Statistics and Programme Implementation, has underlined, the objective is simple yet ambitious: to make the CPI a more accurate mirror of how Indians actually spend today.

The single most important change in the new CPI series is the updating of the item basket and weights using the latest Household Consumption Expenditure Survey (HCES) 2023–24. Over the past decade, the consuming patterns of Indian households have changed. Now apart from food, housing, transport, health, and education, services also figure prominently in his budget. The 2012 basket, designed for a far more food-dominated consumption structure, was increasingly losing relevance. According to Saurabh Garg, Secretary, Ministry of Statistics and Programme Implementation (MoSPI), the new CPI will therefore “materially alter how inflation is measured” by anchoring it in today’s consumption reality rather than yesterday’s habits.

But the changes go well beyond just weights. The coverage of

markets — both rural and urban — has expanded by about 25 per cent, improving geographical and price representativeness. Housing has also been given a methodological upgrade: for the first time, rural housing is

included, employer-provided accommodation is excluded to avoid distortions, and the rent index is now far more holistic. These refinements matter because housing is emerging as a key driver of urban inflation.

Perhaps the most striking feature is the integration of digital India into inflation measurement.

E-commerce prices will now be directly captured for large cities, treating online platforms as an additional “market” alongside

physical shops. Prices of airline tickets, OTT subscriptions, mobile and landline charges will also draw from online sources. In a world of flash sales and algorithmic pricing, CPI will continue to capture transaction prices at a fixed time and date, ensuring consistency between offline and online markets.

The new CPI has expanded the number of consumption divisions from six to twelve. The food and beverages weight appears to fall sharply to about 36.75 per cent.

In reality, much of this decline is due to the reclassification of items such as restaurant meals into services rather than food. When viewed on a comparable basis, the food share has declined far more modestly — reflecting genuine shifts in household spending rather than statistical sleight of hand.

Critics worry that lower food weights could mute inflation during food price spikes. MoSPI’s response is that CPI must reflect what people actually spend, not what they used to. If food’s share

in the household budget has fallen, then its influence on inflation must fall too. At the same time, higher weights for housing and services will ensure that persistent cost pressures in urban India are better captured.

To preserve continuity, MoSPI will release a back-series and an official linking factor between the 2012 and 2024 series.

This will allow policy makers, researchers, and markets to track inflation trends without disruption. For the RBI, a more representative CPI will mean a sharper tool for monetary policy; for wage and pension revisions, a fairer index; and for welfare schemes, a more credible inflation yardstick.

In essence, the CPI rebasing is not about lowering or raising inflation numbers — it is about measuring reality more faithfully. As Saurabh Garg, Secretary of MoSPI, has repeatedly emphasised, the new series is a refinement of a robust framework, designed to keep India’s inflation compass aligned with how its people actually live, spend, and consume in 2024 and beyond.

Strike dilutes workers’ rights

The implementation of the four new Labour Codes marks a significant step toward improving the ease of living for India’s vast workforce, particularly those in the informal and unorganised sectors. These reforms aim to ensure floor-level minimum wages for all workers, without the hurdles of complex industry classifications. By introducing mandatory identity cards for every worker, the Codes seek to empower them with direct access to social security benefits. Regular and compulsory health check-ups will help safeguard workers’ well-being, enabling them to lead healthier and more productive lives. Furthermore, a time-bound grievance redressal mechanism promises to reduce the mental stress and uncertainty faced by aggrieved workers. Collectively, these measures represent a progressive framework focused on dignity, security, and inclusive growth for Indian workers.

However, despite these positive provisions, a section of politically motivated central trade unions frequently resorts to strikes, often without fully considering their



adverse impact. Such strikes result in significant wage losses, particularly for the nearly 380 million workers in the informal economy, who depend on daily earnings for survival. Instead of resolving their issues, frequent strikes tend to weaken the process of constructive and rigorous collective bargaining, thereby undermining the possibility of achieving fair and balanced outcomes for workers and employers alike.

Over time, the repeated call for strikes has proved to be both ineffective and counterproductive. The frequency of such actions has led to widespread fatigue among workers,

causing an overwhelming majority to disengage or ignore these calls. In some cases, a small section of workers is compelled to participate in strikes against their own will,

further eroding the moral legitimacy and collective strength of these movements. Ultimately, this trend diminishes the overall impact of labour welfare measures and weakens solidarity within the workforce.

The broader consequences of strikes extend beyond the workplace. Industrial production suffers, daily commuters face severe inconvenience, and the livelihoods of street vendors, domestic workers,

and small service providers are disrupted. For these workers, even a single day’s loss of income can trigger a livelihood crisis, forcing them to exhaust their limited savings and plunge deeper into economic insecurity.

In emerging economies like India, trade unions must prioritise dialogue, negotiation, and constructive engagement with employers and the Government. A model based on sustained bargaining and cooperative problem-solving can resolve workers’ concerns without disrupting manufacturing, employment, and overall economic growth. In the current context, Indian central trade unions, which are gradually losing their influence, need to introspect and adapt to more effective and forward-looking approaches followed elsewhere.

Indian workers should be organised with a holistic vision that emphasises ease of living, social security, and positive engagement. Resolving disputes through dialogue rather than confrontation will ensure that the operational process remains uninterrupted and the engine of national growth continues to run smoothly. Only through such balanced and pragmatic strategies can workers’ rights be genuinely strengthened and protected in the long run.

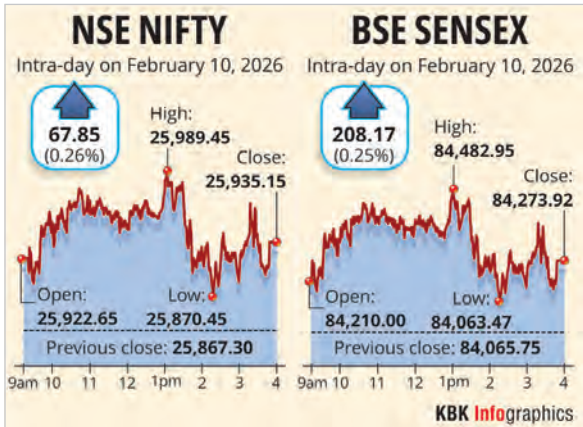
Equity benchmark indices Sensex and Nifty advanced for the third straight session on Tuesday driven by firm global cues and optimism over India-US trade agreement, even as investors turned to profit-booking at higher levels.

The 30-share BSE Sensex climbed 208.17 points, or 0.25 per cent, to close at 84,273.92. During the session, the benchmark jumped 417.2 points, or 0.49 per cent, to hit a intraday high of 84,482.95.

The 50-share NSE Nifty rose 67.85 points, or 0.26 per cent, to finish at 25,935.15. In the intraday session, the index appreciated by 122.15 points, or 0.47 per cent, to hit a high of 25,989.45.

Among the Sensex constituents, Eternal, Tata Steel, Mahindra & Mahindra, PowerGrid, Tech Mahindra, NTPC, Larsen & Toubro, Tata Consultancy Services, Maruti Suzuki India, Axis Bank, Titan and Hindustan Unilever were among the gainers.

On the other hand, HCL Technologies, Bajaj Finance, Bharti Airtel, Asian Paints,



HDFC Bank, UltraTech Cement, Adani Ports and ITC were among the laggards.

“Domestic equities continued their upward momentum, supported by the US trade agreement and positive cues from key Asian markets. A strong resurgence in FII inflows, coupled with rupee appreciation, is further bolstering the investor sentiment, although intermittent profit-booking was visible across sectors,”

Vinod Nair, Head of Research, Geojit Investments Ltd, said. He added that with tariff-related concerns largely easing, the near-term

market trajectory is expected to hinge on Q3 earnings, which have been mixed and below expectations so far.

“Investors are now focused on the combined impact of recent fiscal and monetary measures to revive earnings momentum in the coming quarters,” Nair said.

India ranks 2nd globally in enterprise AI usage; security risks loom

India has emerged as a global powerhouse in artificial intelligence (AI) adoption, ranking second only to the United States in enterprise AI/ML transactions, according to a report by cloud security major Zscaler.

The findings, released in the ‘Zscaler ThreatLabz 2026 AI Security Report,’ come a week ahead of the high-stakes India AI Impact Summit 2026.

The summit, expected to be a gathering of global tech leaders, policymakers, and innovators, is slated to be held in the national capital from February 16-20 and will see global tech leaders in the likes of NVIDIA CEO Jensen Huang, OpenAI CEO Sam Altman, Google CEO Sundar Pichai, Anthropic CEO Dario

Amodei, and Qualcomm CEO Cristiano Amon.

Zscaler pointed out that despite strong momentum in AI adoption in India, significant security challenges persist. These include the weaponisation of agentic AI and a critical gap between innovation and security measures.

The report, drawing on an analysis of nearly one trillion AI and machine learning transactions on the Zscaler Zero Trust Exchange platform from January to December 2025, indicates that enterprises have reached a tipping point where AI is shifting from a productivity tool to a primary vector for autonomous, machine-speed conflict. The study examines AI and ML traffic together, as enterprise AI systems depend on machine learning models to function at scale.



According to the report, Indian enterprises logged a staggering 82.3 billion AI/ML transactions between June and December 2025. This volume accounts for 46.2 per cent of all AI activity in the Asia-Pacific (APAC) region, comfortably placing India as the regional leader.

“India’s growth aligns with continued Government-

backed digital transformation efforts in 2025, alongside major public and private investment in AI infrastructure and skills development. An expanding AI-enabled workforce, combined with cloud-first architectures that enable fast, scalable deployment of AI services, likely contributed to the country’s outsized growth relative to

Silver, gold futures decline as traders book profits, firm dollar

Precious metals declined in the futures trade on Tuesday, with silver falling 2 per cent to ₹2.57 lakh per kilogram, while gold slipped to ₹1.57 lakh per 10 grams as traders booked profits amid weak gains in global markets.

On the Multi Commodity Exchange (MCX), silver for the March delivery depreciated by ₹5,422, or 2.06 per cent, to ₹2,57,198 per kilogram. On Monday, the white metal had surged ₹12,728, or 5.09 per cent, to close at ₹2,62,620 per kg.

Gold futures also witnessed selling pressure, with the April contract decreasing



₹677, or 0.43 per cent, to ₹1,57,389 per 10 grams. In the previous session, the yellow metal climbed ₹2,615, or nearly 1.7 per cent, to settle at ₹1,58,066 per 10 grams.

“Gold and silver prices saw profit-taking and some consolidation on Tuesday, with MCX gold trading around the ₹1.55-1.57 lakh per 10g zone after earlier strength, while silver strug-

gled below key levels near ₹2.56-2.60 lakh per kilogram in intra-day trade,” Gaurav Garg, Research Analyst at Lemonn Markets Desk, said.

He added that precious metals came under pressure as global cues weakened and the US dollar firmed, prompting traders to unwind extended positions and lock in gains after recent rebounds.

US, India to work toward finalising interim pact to concluding BTA

In the coming weeks, the US and India will work toward finalising the interim agreement on trade with a view to concluding a mutually beneficial Bilateral Trade Agreement, the White House has said. The two countries will also continue negotiations to address remaining issues, including services and investment, labour and Government procurement, it said.

Days after India and the US announced in a joint statement the framework for an Interim Agreement regarding reciprocal and mutually beneficial trade, the White House issued a fact sheet on ‘The United States and India



Announce Historic Trade Deal (Interim Agreement).’

The fact sheet highlights key terms of the agreement, including that India will eliminate or reduce tariffs on all US industrial goods and a wide range of US food and agricultural products.

This includes dried distillers’ grains, red sorghum,

tree nuts, and fresh and processed fruit. Certain pulses, soybean oil, wine and spirits, and additional products and India has committed to buy more American products and purchase over \$500 billion of US energy, information and communication technology, agricultural, coal, and other products. (PTI)

Bus crash kills 12

At least 12 persons were killed, and 8 others were injured after a passenger bus fell into the Tamakoshi River in central Nepal, local media reported on Tuesday. The incident occurred around 11 am when the bus enroute to Okhaldhunga from Kathmandu fell into the river near Lilauti in Ramechhap municipality in Bagmati province. Police Inspector Rajan Prasad Timilsina of the District Police Office, Ramechhap, confirmed that five bodies, including one of the bus owner, have been recovered from the site, reported The Kathmandu Post. Residents, security personnel, and rescue teams at the accident site were helping to evacuate the injured. Three people have been rescued till now and sent for treatment. Rescue operation for others trapped in the bus continues.

Fuel shortage hits travel

Air Canada said it is suspending service to Cuba because of a shortage of aviation fuel on the island. Canada's largest airline said it took the decision after the Cuban Government announced aviation fuel would not be available at Cuban airports as of Tuesday. Cuba has been facing a worsening energy crisis amid a US blockade of oil to the Caribbean nation. Canadian tourism is vital to Cuba's economy. Global Affairs Canada, a Governmental office, has said Canada is Cuba's second-largest source of direct investment to the island, particularly in the mining and tourism sectors, which have never fully recovered from the pandemic slump. Air Canada said that in the coming days it will send empty flights southbound to pick up approximately 3,000 customers to bring them home.

Netanyahu to meet with Trump to push for Iran deal

Prime Minister Benjamin Netanyahu is heading to Washington on Tuesday to encourage President Donald Trump to expand the scope of high-stakes nuclear talks with Iran. The negotiations resumed last week against the backdrop of an American military buildup. Israel has long called for Iran to cease all uranium enrichment, dial back its ballistic missile program and cut ties to militant groups across the region. Iran has always rejected those demands, saying it would only accept some limits on its nuclear program in return for sanctions relief. It's unclear if

Iran's bloody crackdown on mass protests last month, or the movement of major U.S. Military assets to the region, has made Iran's leaders more open to compromise, or if Trump is interested in broadening the already difficult negotiations. Netanyahu, who will be in Washington through Wednesday, has spent his decades-long political career pushing for stronger US action toward Iran. Those efforts succeeded last year when the US joined Israel in 12 days of strikes on Iran's military and nuclear sites, and the possibility of additional military action against Iran is likely to come up in this week's discussions. Decisions are being

made. Netanyahu's visit comes just two weeks after Trump's special envoy Steve Witkoff and Jared Kushner, Trump's son-in-law and Middle East adviser, met with the prime minister in Jerusalem. The US Envoys held indirect talks in Oman with Iran's foreign minister on Friday. "The Prime Minister believes that any negotiations must include limiting ballistic missiles and ending support for the Iranian axis," Netanyahu's office said over the weekend, referring to Iran-backed militant groups like the Palestinian Hamas and Lebanon's Hezbollah. Years of nuclear talks have made little progress since Trump scrapped a 2015

agreement with Iran, with strong encouragement from Israel. Iran has shown little willingness to address the other issues, even after suffering repeated setbacks. But the meeting with Trump gives Netanyahu an opportunity to shape the process and may also bolster his standing back home. "Clearly these are the days when decisions are being made, America is expected to complete its force buildup, and it's trying to exhaust the prospect of negotiations," said Yohanan Plesner, head of the Israel Democracy Institute, a Jerusalem-based think tank. "If you want to have influence on the process, only so much can be done via Zoom." (AP)

Court allows lawyer of Imran Khan's party to meet him in jail

Pakistan's Supreme Court on Tuesday allowed a lawyer of Pakistan Tehreek-e-Insaf party to meet incarcerated former prime minister Imran Khan in prison and submit a report about his "living conditions". Khan, 73, has been in jail since August 5, 2023, when he was arrested at his Lahore residence after his conviction in a corruption case. Currently, he has been kept at Adiala Jail, Rawalpindi. A two-member panel of the apex court, comprising Chief Justice Yahya Afridi and Justice Shahid Bilal Hassan, hearing a petition to meet Khan appointed PTI counsel Salman Safdar as amicus curiae with the orders to visit the jail. The court stated that it "considered appropriate that a report regarding the present 'living conditions of the petitioner in jail' be



submitted". Subsequently, the court appointed Safdar as amicus curiae. "Salman Safdar should go to Adiala as a friend of the court," Afridi said, adding that the court has full faith in him. Justice Afridi said that Safdar "should be given full access to the PTI founder so he may be able to file a written response." (PTI)

Iran's top security official in Oman for crucial nuclear talks with US

A top Iranian security official travelled on Tuesday to Oman, the Mideast sultanate now mediating talks between Tehran and Washington over the Islamic Republic's nuclear program aimed at halting a possible American strike. Ali Larjani, a former Iranian parliament speaker who now serves as the secretary to the country's Supreme National Security Council, likely carried Iran's response to the initial round of indirect talks held last week in Muscat with the Americans. Larjani's entourage shared photos of

him meeting with Omani Foreign Minister Badr al-Busaidi, the chief intermediary in the US-Iran talks, with what appeared to be a letter sheathed in plastic and sitting alongside the Omani diplomat. Iran has, in the past, communicated its positions in writing when dealing with the Americans. Iranian media had said Larjani would deliver an important message on the trip. Larjani also met with Oman's Sultan Haitham bin Tariq for nearly three hours, the State-run IRNA news agency reported. Neither Iran nor Oman offered any details on what had been discussed in Larjani's meetings. Larjani was later to



travel to Qatar, which hosts a major US military installation that Iran attacked in June after the US bombed Iranian nuclear sites during

The moves - and Israeli officials' own descriptions of them - put the country at odds with both regional allies and previous statements from US President Donald Trump. Netanyahu has travelled to Washington to meet with him later this week.

Islamic Republic should Trump choose to do so. Already, US forces shot down a drone they said got too close to the Lincoln and came to the aid of a US-flagged ship that Iranian forces tried to stop in the Strait of Hormuz, the narrow mouth of the Persian Gulf. The US Transportation Department's Maritime Administration issued a new warning Monday to American vessels in the strait to "remain as far as possible from Iran's territorial sea without compromising navigational safety."

The strait, through which a fifth of all oil traded passes, is in Iranian and Omani territorial waters.

Palestinians suffer as Israel limits work permits

Hanadi Abu Zant hasn't been able to pay rent on her apartment in the occupied West Bank for nearly a year after losing her permit to work inside Israel. When her landlord calls the police on her, she hides in a mosque. "My biggest fear is being kicked out of my home. Where will we sleep, on the street?" she said, wiping tears from her cheeks. She is among some 100,000 Palestinians whose work permits were revoked after Hamas' October 7, 2023, attack ignited the war in the Gaza Strip. Confined to the occupied territory, where jobs are scarce and wages far lower, they face dwindling and dangerous options as the economic crisis deepens. Some have sold their belongings or gone into debt as they try to pay for food, electricity and school expenses for their children. Others have paid steep fees for black-market permits or tried to sneak into Israel, risking arrest or worse if they are mistaken for militants. Israel, which has controlled the West Bank for nearly six decades, says it is under no obligation to allow Palestinians to enter for work and makes such decisions based on security considerations. Thousands of Palestinians are still allowed to work in scores of Jewish settlements across the West Bank, built on land they want for a future State. Risk of collapse. The World Bank has warned that the West Bank economy is at risk of collapse because of Israel's restrictions. By the end of last year, unemployment had surged to nearly 30% compared with around 12% before the war, according to the Palestinian Central Bureau of Statistics.

Buckingham Palace backs Andrew police probe

BBC, emails released in the US appear to show that Andrew forwarded reports to Epstein including one

from November 2010 sent by his then Indian-origin special assistant Amit Patel, related to official trade visits.

The anti-monarchy group, Republic, reported the matter to the police for "suspected misconduct in public office and breach of official secrets" said a Thames Valley Police spokesperson.

Hindu trader stabbed to death in Bangladesh

A 62-year-old Hindu trader was hacked to death by unidentified men inside his shop in Trishal upazila of Mymensingh in Bangladesh, a local media report said on Tuesday.

The incident took place on Monday night at the Bogar Bazar intersection in the Upazila, Trishal Police Station chief Muhammad Firoz Hossain was quoted as saying by news portal bdnews24.Com. The victim, identified as Susen Chandra Sarkar, was



the owner of 'Bhai Bhai Enterprise' and a resident of Southkanda village, he said. Hossain said the attackers hacked Sarkar with a sharp weapon, left him inside the shop, and closed the shutters. Sarkar's family was

searching for him, and when they opened the shutters to the shop, he was found covered in blood. Sarkar was rushed to Mymensingh Medical College Hospital, where doctors declared him dead. "We have had a rice


business for a long time. No one had any enmity with us. The criminals stole several hundred thousand taka from the store after they brutally killed my father," Sujan Sarkar, the victim's son, said. He demanded that his father's killers be identified quickly and given exemplary punishment. Sarkar's murder is the latest incident of violence targeting the minority community. The Hindu population in Bangladesh has been affected by a series of incidents after the killing of radical youth leader Sharif Osman Hadi in December.

Drought leaves people hungry in Kenya

Drought conditions have left over 2 million people facing hunger in parts of Kenya, with cattle-keeping communities in the northeast the hardest hit, according to the United Nations and others.

In recent weeks, images of emaciated livestock in the arid area near the Somali border have shocked many in a region that reels from the effects of climate change.

In recent years, rainy seasons have become shorter for some communities, exposing them to drought. Normally, animals are the first to die. The livestock losses echo what happened between 2020 and

2023, when millions of animals died in the region that extends from Kenya into parts of Ethiopia and Somalia. At the time, a famine predicted for Somalia was averted by a surge in

international aid. Four consecutive wet seasons have failed in parts of the Horn of Africa, which juts into the Indian Ocean.

The wet season from October to December was

one of the driest ever recorded, according to the UN health agency. Because the rains were brief, parts of eastern Kenya were the driest they have been during that season since 1981.

Some 10 counties in Kenya are experiencing drought conditions, according to the National Drought Management Authority.

The northeastern county of Mandera, bordering Somalia, has reached the "alarm" classification, which means critical water shortages have led to the death of livestock and the wasting of children. The suffering extends into Somalia, Tanzania and even Uganda, where many are threatened by similar weather patterns

and water shortages, the World Health Organization said in late January.

In southern Somalia, an assessment by the Islamic Relief aid group found "shocking food shortages as families flee the region's worsening drought."

In Somalia, long vulnerable to drought conditions, over 3 million people have left their homes, seeking shelter in camps for the internally displaced.

But support is not enough, with 70 per cent of the internally displaced in the city of Baidoa surviving on one meal a day or less, Islamic Relief said in a statement, adding that children in the camps are "showing visible signs of malnutrition and

wasting." Experts say much of what's happening is due to climate change.

The Indian Ocean has become warmer, feeding some of the more destructive tropical storms in recent years. At the same time, drought conditions have become longer, more intense and more severe.

All of that is devastating for Africans whose economic mainstay is rain-fed agriculture, making them vulnerable to extreme weather. Many farmers say increasing temperatures deny livestock pasture and kill their crops.

Africa is particularly vulnerable to extreme weather events because it is less equipped to prepare for natural disasters.

Ex-staff, readers of *Apple Daily* lament the loss of freedoms in HK

Nearly five years after Hong Kong's pro-democracy Apple Daily shut down, its founder, Jimmy Lai, is jailed, the newspaper's former staff and readers are lamenting the loss of the city's press freedoms.

Lai, 78, was sentenced Monday under a Beijing-imposed national security law to 20 years in prison, the longest such sentence so far. His co-defendants, six other former Apple Daily journalists, received jail terms ranging between six years and nine months and 10 years. Officials in both Hong Kong and Beijing defended the case against Lai, with the city's leader, John Lee, accusing the newspaper of inciting violence and poisoning young minds. The

government insisted his case had nothing to do with press freedom, saying the defendants used journalism as a guise to commit acts that harmed Hong Kong and China. There's no question that things are different in Hong Kong without the Apple Daily. Since it folded, the city's once freewheeling press scene has changed drastically; its voice was one of many that have been silenced in the former British colony.

"We've lost a newspaper that spoke for the people, and there's no going back," said William Wong, 66, who had been reading Apple Daily since its founding in 1995. He liked its sharp, to-the-point reporting and critical coverage of current affairs and politics. Former Apple Daily journalists recall their work with pride.

Record snow drought, heat hit western US

A record snow drought with unprecedented heat is hitting most of the American West, depleting future water supplies, making it more vulnerable to wildfires and hurting winter tourism and recreation. Scientists say snow cover and snow depth are both at the lowest levels they've seen in decades, while at least 67 Western weather stations have measured their warmest December through early February on record.

Normal snow cover this time of year should be about 460,000 square miles—about the size of California, Utah, Idaho and Montana - but this year it's only California-sized, about 155,000 square miles, according to the National Snow and Ice Data Centre.

"I have not seen a winter like this before," said centre director Mark Serreze, who has been in Colorado for almost 40 years. "This pattern that we're in is so darned persistent." The snowpack - measured by how much water is trapped inside - in Oregon is not only record low, but 30 per cent lower than the previous record, said Jason Gerlich, regional drought early warning system coordinator for the National Oceanic and Atmospheric Administration.

Much of the US east of the Rockies is snowbound and enduring more than two weeks of bone-chilling abnormal cold, but in West Jordan,



Utah, a suburb of Salt Lake City, Trevor Stephens went to the store last week in gym shorts and a T-shirt.

"Right now there's no snow on the ground," he said in a video interview, looking out his window and lamenting the lack of snowboarding opportunities. "I'd definitely rather have icy roads and snow than whatever is going on out here right now."

Concerns over water supply and wildfires. Ski resorts had already been struggling through a difficult season, but the lack of snow has been persistent enough that concerns are growing about wider effects.

Oregon, Colorado and Utah have reported their lowest statewide snowpack since the early 1980s, as far back as records go.

A dry January has meant most states have received half their average precipitation or even less.

Along with sunny days and higher-than-average temperatures, that's meant little snow buildup in a month that historically gets a lot of snow accumulation across much of the Pacific Northwest and Northern Rockies. Because of heavy rains in December.

US lawmaker introduces bill to end H1B visa programme

A US lawmaker has introduced a bill to end the H-1B visa programme, saying corporations have repeatedly abused this system and imported cheaper foreign labour into America.

US Representative Greg Steube, a Republican from Florida, introduced the "Ending Exploitative Labour Exemptions Act or EXILE Act", a bill that would amend the Immigration and Nationality Act by ending the H-1B visa programme.

"Prioritising foreign labour over the well-being and prosperity of American citizens undermines our values

and national interests," Steube said in a statement.

"Our workers and young people continue to be displaced and disenfranchised by the H-1B visa programme that awards corporations and foreign competitors at the expense of our work-

force. We cannot preserve the American dream for our children while forfeiting their share to non-citizens. That is why I am introducing the *EXILE Act* to put working Americans first again," he said. H-1B visas are used by a large number of Indian professionals to live and work in the US. The Trump administration has intensified its crackdown on immigration, both legal and illegal, imposing new and stringent restrictions on visas such as H-1B.

Describing abuse of the H-1B programme as a national security threat, Trump last year signed a proclamation imposing a \$100,000 fee on new H-1B visas, a move that caused widespread

panic, confusion and concern among Indian professionals. The statement said that more than 80 per cent of recipients of H-1B visas are Indian or Chinese nationals, with priority given to younger workers.

Listing examples of how H-1Bs have "disadvantaged" American workers, it said the visa program has prevented more than 10,000 US physicians from accessing residency programmes by facilitating the arrival of more than 5,000 foreign-born doctors.

It further said that more than 16,000 Microsoft employees were displaced following the approval of more than 9,000 H-1B visas in 2025. (PTI)

Trump's immigration chiefs to testify in Congress following protester deaths

The heads of the agencies carrying out President Donald Trump's mass deportation agenda will testify in Congress on Tuesday and face questions over how they are prosecuting immigration enforcement inside American cities.

Trump's immigration campaign has been heavily scrutinised in recent weeks, after the shooting deaths in Minneapolis of two protesters at the hands of Homeland Security officers. The agencies have also



faced criticism for a wave of policies that critics say trample on the rights of both immigrants facing arrest and Americans protesting the enforcement actions.

Todd Lyons, the acting director of US Immigration and Customs Enforcement, Rodney Scott, who heads US Customs and Border Protection, and Joseph Edlow, who is the director

of US Citizenship and Immigration Services, will speak in front of the House Committee on Homeland Security.

Shehbaz to attend inaugural session of Gaza peace board in US

Pakistan Prime Minister Shehbaz Sharif is expected to attend the inaugural session of the Board of Peace on Gaza to be held next week in Washington. The key meeting is scheduled for Feb 19 at the US Institute of Peace, a leading think-tank.

Diplomatic sources said that PM Shehbaz is expected to travel to the US on Feb 18 to attend the Board of Peace meeting. Pakistan is among eight Muslim-majority nations, including Egypt, Jordan, Indonesia, Qatar, Saudi Arabia, Turkey, and the UAE, that are expected to attend the meeting.

The level of participation from other countries is not known. Pakistan last month formally joined the Board of Peace during an event held on the sidelines of the World Economic Forum in Davos, where President Donald Trump was present. The first meeting of the board would focus on the reconstruction of Gaza. The summit will also formalise the board's mandate and structure.

Trump set to gut US climate change policy, environmental act: White House

The Trump administration is expected this week to revoke a scientific finding that has long been the central basis for US action to regulate greenhouse gas emissions and fight climate change, according to a White House official. The Environmental Protection Agency will issue a final rule rescinding a 2009 government declaration known as the endangerment finding. That Obama-era policy determined that



carbon dioxide and other greenhouse gases endanger public health and welfare.

A White House official, speaking on condition of

anonymity because they were not authorised to confirm the details ahead of an official announcement, confirmed the plans, which were first reported

by the Wall Street Journal.

"This week at the White House, President Trump will be taking the most significant deregulatory actions in history to further unleash American energy dominance and drive down costs," said White House press secretary Karoline Leavitt in a statement.

The endangerment finding is the legal underpinning of nearly all climate regulations under the Clean Air Act for motor vehicles, power plants and other pollution sources that are heating the planet.

Social media addicting brains of children, plaintiff's lawyer argues in landmark trial

Comparing social media platforms to casinos and addictive drugs, lawyer Mark Lanier delivered opening statements in a landmark trial in Los Angeles that seeks to hold Instagram owner Meta and Google's YouTube responsible for harms to children who use their products.

Instagram's parent company, Meta and Google's YouTube face claims that their platforms addict children through deliberate design choices that keep kids glued to their screens.

TikTok and Snap, which



were originally named in the lawsuit, settled for undisclosed sums. Jurors got their first glimpse into what will be a lengthy trial characterised by duelling narratives from the plaintiffs and the two remaining

defendants.

Meta lawyer Paul Schmidt spoke of the disagreement within the scientific community over social media addiction, with some researchers believing it doesn't exist or that addic-

tion is not the most appropriate way to describe heavy social media use.

Lawyers representing YouTube will begin their opening statement on Tuesday. Lanier, the plaintiff's lawyer, delivered lively first remarks where he said the case will be as "easy as ABC" — which stands for "addicting the brains of children." He said Meta and Google, "two of the richest corporations in history," have "engineered addiction in children's brains." He presented jurors with a slew of internal emails, documents and studies conducted by Meta and YouTube, as well as YouTube's parent company, Google.

The central theme of the conclave was employment generation, with Sanjeev Bikhchandani offering key insights into why skilling initiatives often fail to translate into jobs. he once struggled with stage fear, which he overcame only through continuous practice, reinforcing his belief that confidence and competence develop over time.

He stressed about the importance of on-the-job training and apprenticeship-style models, stating that training without real workplace exposure limits employability. According to him, Government schemes that initially appeared apprehensive have significantly strengthened the

skilling ecosystem by encouraging structured learning and industry participation. However, he cautioned that skilling must always lead to employment, calling it the responsibility of industry, institutions and policymakers alike.

Bikhchandani also raised concerns around the migration of women from small towns and villages. Bikhchandani said that mobility must be supported by safety and infrastructure. He pointed out that parents often hesitate to send their daughters to cities due to fears of insecurity. Better facilities such as secure hostels, reliable transport and broader societal support systems are essential to make migration smoother and more acceptable.

Deepak Bagla spoke about the role of innovation and mentorship in shaping a skilled workforce. Sharing his experience of mentoring over 400 children during a hackathon, he highlighted the transformative impact of early exposure and guidance. Bagla emphasised the need to focus on creating social impact rather than

purely financial success, stating that innovation should address real problems at the grassroots level. He also spoke about the importance of collaboration between organisations and institutions to strengthen rural innovation ecosystems.

Navika Kumar briefly touched upon the growth of the orange economy and the need for stronger skill depth and mentorship, particularly for women. She emphasised that women must actively support one another and create professional spaces rather than waiting for opportunities to be granted.

The conclave concluded with a creative touch as the afternoon featured do-it-yourself skill activities, including lip balm making, along with tarot card readers, reinforcing the conclave's blend of professional insight and experiential and practical learning. The event stood as a example that skilling is not merely about employment but about empowerment, confidence and collective responsibility in shaping a truly inclusive Viksit Bharat.

After hectic parleys and back-channel talks which also included intervention from Sri Lankan President Anura Kumara Dissinayake and the Bangladesh Cricket Board, which requested

Belgium winning 22 matches, India winning 11, and two matches ending in draws. Against Argentina, however, India hold a stronger record, winning 10 of their 19 meetings since 2013, compared to Argentina's seven wins.

Speaking ahead of their opening match, India captain Harmanpreet Singh said, "I am very happy to see youngsters like Amandeep Lakra, Manmeet Singh and Rosan Kujar earning their opportunities in the squad. They have performed exceptionally well in the recent Hero Hockey India League and have shown great potential.

This is the right time for them to step up at the international level, and I am confident they will make the most of this opportunity.

Mbappe's scoring streak for Madrid

Kylian Mbappe's latest impressive scoring run with Real Madrid has brought up comparisons to Cristiano Ronaldo. After Mbappe scored his 23rd goal in 22 Spanish league games in Madrid's 2-0 win at Valencia on Sunday, coach Alvaro Arbeloa said the France striker could be well on his way to matching the success of Ronaldo at the Spanish powerhouse.

"What Cristiano achieved seemed extraterrestrial, something impossible to match and no one could come close," Arbeloa said.

"Mbappe has a long way to go because Cristiano was



here for many years, but he has the conditions to follow in his footsteps, and you never know if he'll be able to surpass him. But if anyone can, it's Kylian." The 41-year-old Ronaldo, currently playing in Saudi Arabia, played for Madrid from 2009-18, breaking nearly every club record. The 27-year-old

Mbappe joined the Spanish powerhouse last season and quickly matched some of the numbers of the Portugal star. Mbappe scored 59 goals in 2025 to equal's Ronaldo's club-record tally in 2013. At the time, Mbappe called Ronaldo his "idol, the best player in the history of Real Madrid and a reference point

in world soccer. It's an honor for me." Mbappe started this year on a roll and with even better numbers, having scored nine goals in seven matches. He needed 11 games to reach nine goals last year. He has 43 goals in 35 appearances for club and country this season.

"It's a great fortune, because right now he's the best player in the world with what he's proving day in and day out, game after game," Arbeloa said of Mbappe. Arbeloa, who took over the club's helm this year to replace Xabi Alonso, was a former Madrid defender who was a teammate of Ronaldo at Madrid, playing six seasons with him from 2009-2016.

Nitish Kumar Reddy was the only silver lining for Andhra as the India all-rounder batted resolutely to

make 90 off 144 balls with seven fours and two sixes.

Al-Nassr hopeful Ronaldo to return for Asian Champions League Two

Cristiano Ronaldo is yet to win a major trophy since arriving in Saudi Arabia, and Al-Nassr will be hoping the 41-year-old Portuguese star returns to action on Wednesday to help the Riyadh club move closer to silverware. Al-Nassr takes on Arkadag of Turkmenistan with a place in the quarterfinals of the Asian Champions League Two on the line.

Ronaldo hasn't played any part in Al-Nassr's most recent two games in the Saudi Pro League amid reports he was unhappy with the way the club is being funded, particularly after watching rival Al-Hilal sign Karim Benzema in last month's transfer

window. Al-Nassr, Al-Hilal, Al-Ittihad and Al-Ahli are all majority owned by Saudi Arabia's Public Investment Fund. In a statement, the SPL outlined that no player is bigger than the club or the league. "The Saudi Pro League is structured around a simple principle: every club operates independently under the same rules," the league said. "Cristiano has been fully engaged with Al-Nassr since his arrival and has played an important role in the club's growth and ambition. But no individual — however significant — determines decisions beyond their own club."

Despite the absence of the five-time Ballon d'Or winner, Al-Nassr beat reigning champion Al-Ittihad 2-0



on Friday. Ittihad is the only one of three Saudi teams in the top-tier AFC Champions League Elite not to have secured a place in the round of 16, with two group games remaining. Despite losing star striker Karim Benzema last week to Al-Hilal, which has a history of making high-profile signings, including Neymar from Paris Saint-

Germain in 2023, Ittihad will advance to the next round if it defeats Al-Gharafa of Qatar on Tuesday.

The top eight in each of the tournament's two 12-team groups — divided geographically into East and West Asia — qualify for the second round. Al-Hilal leads the western zone and is the only team with a perfect record of

six wins from six, meaning coach Simone Inzaghi can choose to rest players. Al-Ahli, which won its first Champions League title in May, is also guaranteed a spot in the knockout stage.

In the eastern zone, only Vissel Kobe has clinched qualification, but Japan will have three teams in the round of 16 if both Sanfrecce Hiroshima and Machida Zelvia win this week.

The pressure is on China's three representatives, which occupy the bottom three positions. Chinese champion Shanghai Port is in last place and on the verge of being ousted from the tournament. Wins for Chengdu Rongcheng and Shanghai Shenhua would keep both teams in contention.

Villarreal inflicts heaviest defeat of Espanyol in La Liga this season

Netherlands keep Super 8 hopes alive with win over Namibia

Bas de Leede hit an assured 72 as the Netherlands kept their Super 8 hopes alive in the men's T20 World Cup with a confident seven-wicket win against Namibia in their Group A match here Tuesday, bouncing back from a painful defeat to Pakistan from a strong position.

The Netherlands produced a tidy, disciplined bowling performance to restrict Namibia to a modest 156 for 8 in the clash between the associate nations despite a spirited middle-overs recovery from the African side.

This is Namibia's first outing of the tournament, and it showed in patches.

Short of match time in recent weeks, with their last T20I being that last-ball win over South Africa in October 2025, they took time to find rhythm.

With the Indian team not involved, the stands were sparsely populated, but the cricket on display was of good quality.

Jan Frylinck (30) and Jan Nicol Loftie-Eaton (42) revived the Namibian innings with their steady 50-run stand after an early setback while JJ Smit (22) provided fire-works down the order. However, the late flourish did not come for Namibia as they settled for a modest total on a sporty wicket.

Bas de Leede, who remained unbeaten, and

Colin Ackermann (32) did the bulk of scoring after opener Mochale Levitt (28) provided a quick start as Netherlands overhauled the target without fuss.

Netherlands next play the USA in Chennai on Friday while Namibia have a tough test against hosts India at the same venue on Thursday.

The Dutch, who had lost to Pakistan in Colombo after dictating terms for large parts of the match, showed far greater composure this time. After losing Max O'Dowd (7) early, Levitt provided early momentum with a brisk innings before falling in the powerplay.

Ackermann steadied the innings with a fluent 32,

forging a vital stand with Bas de Leede.

De Leede anchored the chase with a measured knock off 48 balls, mixing caution with aggression. He hit nine boundaries, including four sixes.

Skipper Scott Edwards finished things off in style, scoring an unbeaten 18, as the Netherlands reached 159 for three in 18 overs. Namibia's bowlers struggled to contain the Dutch middle order once the platform was set.

Earlier, the Dutch set the tone early. Pacer Logan van Beek (2/13) hit the deck hard with the new ball, while off-spinner Aryan Dutt (1/13) bowled a probing, miserly spell that choked the scoring.

Dutt provided the first breakthrough when he lured Nikolaas Davin Steenkamp (6) down the track. Steenkamp walked forward to negate the spin but missed the line and length completely, allowing Scott Edwards to complete a sharp stumping.

The Netherlands largely controlled the powerplay, conceding just 29 runs in the first five overs. Namibia managed only one maximum in that phase, Frylinck briefly breaking the shackles by pulling Klaassen for six.

Seeing the impact Dutt was making, Dutch skipper Edwards introduced Colin Ackermann, but the off-break bowler was handled confidently. (PTI)

Shaken by Nepal, England aim to step up game in T20WC clash against Windies

In their absence, Nathan Ellis is expected to lead the pace attack but even he has an injury cloud hovering over him and is yet to play a game since missing the Big Bash League (BBL) final with a hamstring issue.

Seasoned leg-spinner Adam Zampa is entering the tournament after overcoming a groin issue, which made it possible for him to be avail-

able for the group stage. Considering the conditions across the sub-continent, Zampa will be critical to Australia's hopes in the tournament, which they last won in 2022. The team lost in the semifinals of the last edition to India.

While leading the spin attack, the experienced Zampa will look to form a fruitful partnership with fellow tweakers Cooper Connolly and Matt Kuhnemann with all four of the side's group stage matches to be played in Sri Lanka.

While the bowling unit no doubt wears a depleted look compared to their attacks of the past, Australia have the requisite firepower in batting and the team also features a long list of all-rounders, who can trouble most sides on their day.

Australian chair of selectors George Bailey had said they had the luxury of focusing on a player group likely to handle the conditions in India and Sri Lanka with aplomb, even as several players came into the tournament under a fitness cloud.

My experience will help Afghan players: Rashid

Skipper Rashid Khan said the familiarity with South African players through his SA20 stint will help him pass useful information about the opposition to his young Afghanistan teammates ahead of their T20 World Cup match.

Rashid has been a constant presence in the SA20 over its four editions, and the premier spinner is coming to the ICC showpiece after spending a month in South Africa with MI Cape Town.

"I think it helps you to share that information with the team. Like, personally I've been playing for long, played with each and every one (SA players) for a long time," Rashid said on the eve of the match against the Proteas.

"I think it does help the youngsters who haven't played and give them the kind of idea of what's going to happen, what their mindset is, and I think it really helps." Spent one month there and I think that information you bring to the

national team, it really helped the youngsters," he added.

Rashid also opined that both Afghan and South African players have equal advantage in the match because of their familiarity with Indian conditions through the IPL.

"It definitely helps, but even if you have a good idea, still you don't know how the wicket will behave. If you play in the IPL, it's different, but when you play in the ICC event, it's different.

"There is a pressure when you play for your country. So, it's a different feeling. But to be honest, no one around the world will tell you how the wicket will behave before the game. I think they know the condition here as well. So, it's not just like me playing a lot and it's going to be favouring us, no, I think it's equal for everyone," he noted.

The 27-year-old also hoped for his pace bowlers to come up with a better effort against South Africa, after they failed to sustain the pressure created by spinner Mujeeb Rahman in the match against New Zealand at Chennai.



Afghanistan look to bounce back against South Africa

With only two teams slated to make the Super Eight stage from each group, Afghanistan find themselves in a must-win situation when they take on an in-form South Africa in their Group D match of the T20 World Cup on Wednesday.

South Africa are perched at the top, head and shoulders above the rest as their 57-run victory over minnows Canada bolstered their Net Run Rate to 2.850 along with two points.

On the other hand, a five-wicket defeat to New Zealand (+1.162) saw Afghanistan slip to third with a Net Run Rate of -1.162, which they would have to



improve in order to advance to the next round.

Therefore, the competition in Group D can be expected to be intense in the coming days as Afghanistan are among the teams to beat in the tournament. South Africa, the last edition's runner-up, and the resolute Kiwis will heat up the battle as Group D is set to witness some tension in the first round. Afghanistan

bowled wayward. Afghanistan fast bowlers collectively failed to put pressure on the Kiwis and even their skipper Rashid had an off day, giving away 1/36 in his four overs. Mujeeb Ur Rahman's 2/31 was the only bright spot for the Afghans with the ball, who will be determined to make significant improvements as they move to the world's biggest stadium.

Rashid's experience of playing here in the IPL will be crucial for Afghanistan, who need a win to bounce back and resurrect their campaign. Additionally, their bilateral record against South Africa will also weigh heavily on the Afghans who have lost each of their three matches in history.

Marsh backs Australia's inexperienced bowling attack to do the job

Australia skipper Mitchell Marsh is confident that his side's relatively inexperienced bowling attack will rise to the challenge in the absence of frontline pacers Pat Cummins, Mitchell Starc and Josh Hazlewood during the T20 World Cup.

This will be the first major ICC tournament since 2016 where Australia will not feature a single member of their famed pace trio.

While Starc retired from the format last year, Cummins and Hazlewood have been ruled out of the tournament due to injuries.

In their absence Nathan Ellis, Ben Dwarshuis and Xavier Bartlett will spear-

head the pace department.

"Guys like Patty (Cummins) have played a lot for us over the last few years due to his hectic schedule and over the last 12 months guys like Benny Dwarshuis and Xavier Bartlett have played pretty much all of our games," Marsh said on the eve of their opening game against Ireland. "We've got great confidence that they've been able to do a role for us, and they've excelled in some games. So we're confident with the group that we've got here. And we've built that for the last 12 months."

Australia head into the tournament on the back of a historic 0-3 T20I series loss to Pakistan, which included their heaviest defeat in the format - a 111-run drubbing.



"It (Pakistan tour) was some great learnings from that tour. We had some young guys that got exposed to those condi-

tions for probably the first time in their career.

"We take the lessons and we move on and we obviously welcome some experi-

enced guys back into our group for this part for this tournament so yeah we've certainly parked that and we move on and we look forward to the World Cup," Marsh said.

Australian batters struggled against spin during the Pakistan tour, and Marsh admitted that the team needs to adapt quickly, especially with Sri Lankan conditions expected to favour slower bowlers.

"We certainly know the conditions that we're going to be faced with and I think most teams will have, I guess, similar ideas on how they're going to go about it. So we're prepared for that and we're ready to go," he said.

"Look, I think we certainly want to be positive in the

way we go about things. I think in these conditions, it's just about being really clear on how you're going to go about it and playing what's in front of you," Marsh said ahead of Australia's T20 World Cup opener against Ireland.

"The word adaptability has been thrown around in our team meetings so far and just adapt to whatever situation is put in front of us and get the job done," he added. Marsh confirmed that Tim David will miss Australia's tournament opener as he continues to recover from a hamstring injury.

"He's not available tomorrow, but we'll certainly see him come back into contention over the next few games," Marsh said.

'Cricket is a bit behind': Buttler on using walkie-talkie

Senior batter Jos Buttler said cricket is relatively behind other sports in relaying messages to on-field players, after head coach Brendon McCullum was seen communicating with England captain Harry Brook through a walkie-talking during drinks break in their T20 World Cup clash against Nepal.

But in some sports like Formula 1, Race Engineers

direct drivers in real-time via radio, covering strategy, engine settings, tire management, and safety info. In football, managers are allowed to communicate with players from the sidelines. "I think so, there's (been) walkie-talkies for a while to be fair.

But then the communication from top to bottom has always been really good in the group," Buttler told reporters when asked if the motive behind using walkie-



talkie was way for McCullum to have a more hands-on approach.

"Baz can sit with his feet up and his sunglasses on and look very relaxed, but he's as sharp a coach as I've ever worked with. He doesn't miss a beat," Buttler said.

"I think also for cricket in general, actually, coaches are getting more involved in real-time in cricket, I've played in the IPL, at Gujarat (Titans), Ashish Nehra is very active on the boundary rope.

Sri Lanka President thanks Pak PM for India match boycott withdrawal
